Report AG-21-001 from Director and Chief Curator Re: Tom Thomson a. Art Gallery Update - January 2021

The Director provided an overview of her update report.

The gallery's digital portal has received positive feedback from virtual visitors, and has been featured in local media, as well as in media outlets from outside the region. While done with a very small budget, developing digital strategies could be enhanced with proper equipment to which end, the Gallery is applying for funding through an RT07 grant.

The gallery team is working on developing scenarios for re-opening based on when the current COVID-19 lockdown is lifted.

The Director has been using resources and strategies from the Canadian Art Museum Directors Organization and other sector organizations to help staff stay connected, productive, and motivated during the COVID-19 lockdown and working from home. Staff also have weekly team check-ins, staff meetings, and smaller group meetings.

The Director is aiming to have a draft of the Strategic Plan prepared for the Advisory Committee at the March 3, 2021 meeting for feedback. Once finalized the Strategic Plan will be accessible on the gallery's website.

 Report AG-21-002 from Director and Chief Curator Re: Establishing an Ad Hoc Committee of Council to Explore the Expansion of the Tom Thomson Art Gallery

The Director gave an overview of her report recommending the formation of an Ad Hoc Committee of City Council to create an expansion plan for the current gallery facility, and reviewed her presentation "Tom Thomson Art Gallery Facility Challenges 2021".

An expansion of the gallery facility is essential as the facility has reached a critical state due to aging infrastructure, a growing art collection and a national status that demands suitable space for display, programming, innovation and staff, and is necessary for the gallery to continue growing as a cultural cornerstone for both Owen Sound and the larger Grey-Bruce area.

The Director participated in a webinar by ArtsBuild Ontario titled "Building/Renovating Create Spaces: Concept, Feasibility & Design" and will share resources from this webinar with the Advisory Committee, as it contains information relevant to any plan to be developed by the proposed Facility Expansion Ad Hoc Committee.

The Advisory Committee discussed the ramifications of the facility challenges illustrated in the presentation attached to the report, and especially noted the working conditions of staff and the inability for the gallery to receive significant art donations in its current state.

The Advisory Committee agreed that the gallery facility is in critical need of expansion and updating.

The Advisory Committee specified that the mandate of the Tom Thomson Art Gallery Facility Expansion Ad Hoc Committee would be the development and implementation of an "expansion plan" for the gallery facility (not the oversight of an expansion project) and asked that the draft Terms of Reference be amended to reflect this clarification.

Additionally, the Advisory Committee clarified that the mandate of the Tom Thomson Art Gallery Facility Expansion Ad Hoc Committee would be met once the "expansion plan" was complete, (not the facility

expansion itself) anticipating that the expansion plan development would take approximately 18 months, and would be completed by the end of the current City Council's term in September 2022. The Committee asked that the draft Terms of Reference be amended to reflect this timeline for the development of the expansion plan, and remove reference to any timeline for the actual expansion project.

There has been a great response from 25+ community retail locations throughout the region. The calendar campaign is projected to bring in a profit of \$18,000 for the gallery.

There have been 30 of the complimentary memberships redeemed thus far.
