9.a Presentation from Mayor Boddy Re: Volunteer of the Year Award

Mayor Boddy recognized Thom and Pat McDonough as the co-recipients of the 2021 Volunteer of the Year Award. Mayor Boddy noted that Thom McDonough was nominated by OSHaRE where he has held a number of positions since 2015. Among other volunteer commitments, he has volunteered up to 70 hours in one week during the peak of the COVID-19 pandemic. Described by his peers as "volunteering with a genuine smile, you know he cares".

Mayor Boddy advised that Pat McDonough was also nominated by OSHaRE where he has held several positions since 2013. Described by his peers as "approachable, dependable and willing to struggle and serve". Pat continues to spend 6-7 days each week volunteering where his colleagues say, "he's a blessing and when you are in his company, you feel perhaps that you are a blessing too".

Next, Mayor Boddy recognized Jan Chamberlain as the recipient of the 2021 Senior Volunteer of the Year Award. Mayor Boddy noted that Jan Chamberlain has an extensive volunteer history through a number of different boards over 25 years. Described by her peers as "professional and bringing a compassionate voice to everything she is involved with", "changemaker", "strong sense of judgement and compassion" and enthusiastic and tireless in her efforts to educate others".

17.a Tom Thomson Art Gallery Facility Expansion Ad Hoc Committee

Councillor Thomas advised that the Tom Thomson Art Gallery Facility Expansion Ad Hoc Committee has recently been discussing the expansion of the Committee mandate to include additional potential gallery sites rather than solely trying to redevelop and expand on the existing site. Councillor Thomas added that a motion respecting an expansion of the Ad Hoc Committee's mandate was passed by the Committee on October 29, 2021, but the minutes will not come before Council for approval until November 29, 2021. Due to the time sensitive nature of this Committee's mandate, Councillor Thomas put forward the following motions.

17.b Youth Advisory Council

Councillor Merton advised that she attended a virtual workshop hosted by the Arran-Elderslie Youth Advisory Council. The Youth Advisory Council was formed in 2019 as a result of the municipality's economic goals to develop youth engagement opportunities. Councillor Merton advised that she was impressed by the commitment and excitement of the Youth Council members and their positive view of their community. Youth retention, education, exposure, and representation are important ways to encourage growth. Councillor Merton added that municipalities across the province have found Youth Councils to be an effective youth engagement and retention strategy. Youth are more likely to return to a community after post-secondary education, or stay in the community after discovering and experiencing the opportunities available to them in their formative years.

Councillor Merton advised that municipal governments can provide leadership by nurturing a sense of belonging for young people in their communities through the creation of meaningful experience that empower youth advocacy and involvement. In Owen Sound, youth engagement has been identified as part of the strategic plan refresh under 'prosperous city'. Municipal councils and staff can facilitate community connections between the youth, different communities, and create potential pathways for young people to return to their communities after leaving for work or study. Councillor Merton encouraged the Youth Council to connect with the City of Owen Sound to make a presentation on Youth Advisory Councils and municipal involvement.

17.c Recent Event Attendance and Question for the Director of Public Works and Engineering

Deputy Mayor O'Leary asked the Director of Public Works and Engineering when a report on the 10th Street Bridge will be coming forward. The Director of Public Works and Engineering advised that the report will be presented to the Operations Committee on Tuesday, November 9, 2021.

Deputy Mayor O'Leary advised that he recently attended an event put on by the Optimist Club that featured Kaleb Dahlgren, a survivor of the Humboldt Broncos bus crash. Deputy Mayor O'Leary noted that Kaleb is an advocate for those with diabetes, and serves as an inspiration for trying to help his fellow teammates after the bus crash despite being severely injured himself.

17.d Zonta Club Event

Councillor Tamming advised that he was recently invited to attend the Zonta Club's 35th Anniversary event as a representative of City Council. Councillor Tamming noted that the Zonta Club is a local women's group that advocates for women's rights throughout Canada and the world. The Zonta Club is currently growing its operation and is always looking for more volunteers.

17.e Mayor's Update

Mayor Boddy advised that he and the City Manager recently toured Hydrogen Optimized. Mayor Boddy noted that the \$22 million dollar program at Hydrogen Optimized achieved a significant milestone on the path to becoming the world's largest green hydrogen production systems that will be manufactured in Owen Sound. Mayor Boddy advised that hydrogen is expected to account for approximately 25% of the solution as we move forward to reach net zero carbon emissions by 2050.

Mayor Boddy advised that he recently joined City staff and some Councillors in participating in an annual emergency exercise. This exercise allowed those involved to review the roles they would play in the event of an emergency. Mayor Boddy thanked the City's Emergency Management Coordinator for organizing this exercise.

Mayor Boddy noted that he recently attended the Billy Bishop Museum's 21st Annual 'Honouring Our Local Veterans' at the Owen Sound Legion and noted all those who were honoured at the ceremony.

Mayor Boddy advised that he and the City Manager will be touring the Nuclear Innovation Institute to explore innovation and economic opportunities in the area to see if the City can learn from them. The Nuclear Innovation Institute seeks to find ways, and takes advantage of clean power.

Mayor Boddy noted that November 11 is Remembrance Day, adding that ceremonies will be taking place and that more details will be provided once COVID-19 safety plans have been completed. Remembrance Day ceremonies can be viewed on Rogers cable and heard on CFOS.

Mayor Boddy advised that Council has a busy meeting schedule in November starting with the 2022 budget meeting taking place on November 12, 2021. There will be no Regular Council meeting on November 15, but rather, a Special Meeting commencing at 4:30 p.m. There will be a Special Meeting on November 22 for the annual meeting between the City of Owen Sound and the Police Services Board.

Lastly, Mayor Boddy noted that the 26th Annual Kiwanis Santa Claus Parade will be taking place on Saturday, November 20, 2021, at 5:00 p.m., followed by the Festival of Northern Lights fireworks at 6:00 p.m.
