1. CALL TO ORDER

Chair Farrell called the meeting to order at 1:02 p.m.

8. REPORTS OF CITY STAFF

8.a Verbal Report from the Engineering Technologist Re: New Pedestrian Cross-Overs in the River District

The Engineering Technologist advised that the pedestrian cross-over (rainbow crossing) on 8th Street East has been completed and is a hard-wired system that is fed off the grid for electrical power. The two new systems that have not been actuated yet are solar powered. These cross-overs will be located on 2nd Avenue East in the 800 and 900 blocks. An inspection is scheduled for next Tuesday by the Electrical Safety Authority and the cross-overs will be operational following that inspection.

Each of the cross-overs has an audible button on either side of the roadway that says "yellow lights are flashing", approach signage indicating that there is a cross-over ahead, a no passing sign, and flashing beacons that will flash for 22 seconds. It is a requirement under the *Highway Traffic Act* that vehicles are legally bound to stop when the lights are flashing. These cross-overs are approved Ontario Traffic Manual crossings and the current crosswalks on 2nd Avenue East are non-conformant with the Ontario Traffic Manual which is why they are being replaced. These new cross-overs will improve pedestrian safety in the River District.

In response to a question from Committee, the Engineering Technologist advised that there is currently not a beat tone on the posts for the cross-over at 8th Street East. Member Anderson noted that this will make it extremely difficult for a

person with visual impairment to find the audible button. The Engineering Technologist will follow up with the supplier and find out if the software will allow the beat tone to be actuated on these cross-overs.

In response to a question from Committee, the Engineering Technologist noted that the equipment for each cross-over cost approximately \$11,000, the new poles for the overhead signage for each cross-over cost approximately \$3,500, plus the labour to install the equipment.

Committee members suggested that a "New" sign be installed before the crossover for the short-term. It was also suggested that capital projects go forward to Committees first for evaluation prior to construction. This is a project that is relevant to this Committee and members could have provided valuable input and feedback on the design and functionality prior to construction.

This staff report will come forward to the Operations Committee for consideration at its meeting on November 9, 2021. These minutes would then go forward to Council for review and approval at its meeting on November 29, 2021. If approved by Council, staff will issue a Request for Proposals based on this staff report and approved recommendations.

Committee members discussed the Mobility Transit Application Form and suggested that it may be time for staff to review and update the application form to ensure that it is inclusive of all types of disabilities.
