  - a. all documents necessary to transfer leased lands, known as Parts 1 and 2 on Reference Plan 16R6924, to the City; and
  - b. all documents necessary to consent to the Application for Absolute Title by Hansa Financial & Property Management Inc. and to waive notice of the application."

  - f. Removal of garbage and recycling-related to the operation of the patio and mobile food unit;
  - g. Connection to services with respect to disposal of greywater only;
  - h. Updated lease agreement with Transport Canada; and
  - i. Other conditions recommended by the City solicitor;
- 2. Authorizes Experience Grey Bruce to make an application to the AGCO for a licensed patio and to permit alcohol sales and consumption on the subject lands;
- 3. Directs staff to execute a Street Vendor Agreement with Bombshell Stella's subject to:
  - a. the City's standard requirements, save and except the hours of operation which will begin at 5 a.m.; and
  - b. a fee of \$350 per month; and
- 4. Directs staff to bring forward a report regarding the updated lease for a portion of the West Side Boat Launch with Transport Canada."

## 17. DISCUSSION OF ADDITIONAL BUSINESS

17.a Municipal World Course and Community Foundation Housing Report

Councillor Merton advised that she recently completed a course titled 'Civilitas: Respectful Leadership in Local Government'. Councillor Merton noted that incivility is threatening the discourse of councils, boards, and staff and is creating a culture of reactivity rather than personal reflection. Councillor Merton advised that the lack of civility is negatively impacting the mental and physical health of civil servants and is preventing individuals from running for board and council positions. The Civilitas course addressed the tasks of creating respectful leadership, addressing interpersonal workplace incivility, and developing strategies to promote organizational civility.

Councillor Merton advised that on May 12, 2022 the Community Foundation Grey Bruce will be releasing its Vital Focus on Housing report at the Harmony Centre in Owen Sound.

17.b Earth Film Festival

Councillor Greig advised that the Grey Sauble Conservation Authority (GSCA) Foundation has resumed its annual Earth Film Festival after a two-year break due to COVID-19. The festival will take place on May 19, 2022 and will feature an interactive butterfly presentation and the screening of a Canadian production titled 'Flight of the Butterflies'. The event raises funds to benefit local conservation projects. Tickets can be purchased at the Roxy Theatre.

17.c Increasing Housing Density and Potential Partial Closure of 2nd Avenue East

Councillor Tamming discussed the concept of housing density in Owen Sound by developing walk-up apartment complexes that could be located in residential neighbourhoods. Councillor Tamming noted that these developments should not be high-rise apartments, but rather, low to mid-rise to ensure that the development is in keeping with the aesthetic of the neighbourhood.

Councillor Tamming advised that he often spends time in Owen Sound's downtown core and has often contemplated various ways to enhance the area. Councillor Tamming noted that a potential option to further beautify the area would be to partially close a portion of 2nd Avenue East from approximately the Victoria Day long weekend to the Labour Day long weekend in future years, pending support from the local community. Councillor Tamming noted that the area could host outdoor dining, pavilions, and other shops and inquired if such an idea might be possible for 2023. The Director of Community Services advised that a report on patio furniture will be presented in the coming months and noted that the River District Action Plan contains various actions and strategies for development, including the creation of an engaging space by researching and investigating the potential closure of a section of the River District to vehicle traffic on an ongoing and scheduled basis.

Mayor Boddy advised that the Arts and Culture Awards were celebrated on May 1 and congratulated Christy Taylor, Tyler Boyle, Paige Warner, Earth Day Grey-Bruce, and Elder Shirley John for their achievements.

Mayor Boddy advised that on May 6 the Owen Sound Sports Hall of Fame celebrated their 2020 inductees and congratulated athletes Mark Cochrane, Bayleigh Hooper, Steve Irving, and Brian Kazarian; builders Terry King and the late John 'Jack' Milne; and teams 1968 Owen Sound Highsteppers Patti Cakes, 1968 TNT Highsteppers, and 2018 U23 Selects Fastball on their achievements.
