## 9. DEPUTATIONS AND PRESENTATIONS

9.a Deputation from David Adair, Georgian Bay Symphony Re: 50+1 Years of Music

Sandy Stevenson, Director on the Georgian Bay Symphony Board of Directors provided a deputation on the Georgian Bay Symphony's 50+1 Years of Music. Ms. Stevenson provided an overview of the history of the symphony. Ms. Stevenson advised that the Georgian Bay Symphony is in its 51st year, has approximately 50 musicians, and plays five concerts per year. The symphony was required to pivot due to COVID-19 and began offering its concerts virtually. Ms. Stevenson shared two video clips of symphony members performing, and then shared a video that highlights the upcoming concert season.

## 10. PUBLIC QUESTION PERIOD

10.a David McLaren, Neyaashiinigamiing resident asked the following question respecting housing and homelessness:

What policy does the City of Owen Sound have for dealing with homelessness and addictions?

The City Manager advised that the City issued a memo in February 2022 that specifically discusses homelessness and how the City coordinates its actions with the County of Grey who lead homelessness initiatives with the province. The City and the County are also working with the Federation of Canadian Municipalities (FCM) and the Association of Municipalities Ontario (AMO) who take leads on this portfolio.

Respecting addictions, Mr. Simmonds advised that AMO recently released a document titled 'An Integrated Approach to Mental Health and Addictions' which was recently supported by Council.

Deputy Mayor O'Leary added that the County of Grey has recently transferred housing initiatives from the YMCA to the County. Each homeless person will be

provided with a case manager who will work with them to find housing and address the root cause of their homelessness.

10.b Rob Rolfe, Owen Sound resident asked the following question respecting housing and homelessness:

Will Council support immediate action to develop and adopt a plan to address the issue of homelessness?

The Director of Community Services advised that the City's Official Plan references homelessness and affordable housing, noting that the County of Grey has completed a housing and homelessness strategy with targets for affordable housing. The City is working in consultation with the County to achieve the targets of the County's housing and homelessness 10-year plan when considering new development applications.

10.c Ray Botten, Owen Sound resident asked the following question respecting housing and homelessness:

Is it possible to be kind and listen to the needs of those who are homeless?

Mayor Boddy thanked Mr. Botten for his question.

10.d Ray Whitfield, Owen Sound resident asked the following question respecting housing and homelessness:

What is the City doing to assist the homeless population in Owen Sound?

Deputy Mayor O'Leary advised that all levels of government must collaborate to address the issue of homelessness as it is something that is happening nationwide.

Mayor Boddy advised that the County of Grey is working with the homeless population by locating temporary housing while working to address the underlying causes of each individual's homelessness. Owen Sound Police Services and the Canadian Mental Health Association are reaching out to the homeless population to ensure they are being taken care of.

10.e Chris Neudorf, Owen Sound resident asked the following question respecting homelessness:

Can the City take immediate action to provide some relief to the homeless population in Owen Sound before winter?

Mayor Boddy advised that the Owen Sound Police Service and Canadian Mental Health Association's main priority is keeping everyone alive so they may be helped and treated.

- 10.f Patti Waterfield, Owen Sound resident asked the following questions respecting affordable housing:
  - 1. Is the proposed development at the former RCA site going to be affordable housing?
  - 2. Can Owen Sound create a policy that forces developers to develop mixed housing?

Mayor Boddy advised that the proposed development will not be an affordable housing development as it is a private development. Mayor Boddy noted that 22 percent of houses constructed in Owen Sound in the past five years are considered affordable and that the Owen Sound Housing Company is currently in the process of opening Odawa Tower, a 60-unit affordable housing complex.

Mayor Boddy added that private builders do not have the ability to make their developments affordable due to the cost of construction and noted that funds will need to be provided by other levels of government for developers to be able to construct affordable housing units. There are funds available through the Canadian Mortgage and Housing Corporation for developers to construct attainable housing.

Respecting a policy that forces developers to develop mixed housing, Mayor Boddy advised municipalities must operate in accordance with Ontario planning laws and policies and creating such a policy would contravene these laws and policies and would not be permissible.

- 10.g Jim Ansell, Owen Sound resident asked the following questions respecting the birds at Harrison Park:
  - 1. Is the care of the birds at Harrison something that is contracted out, or done by City staff?
  - 2. Is the City going to continue to operate the bird area at Harrison Park?

The Director of Community Services advised that the care of the birds is done by the City's Parks Division staff. Ms. Coulter advised that the pheasant area was isolated in the spring when the avian flu was discovered. The City has been following recommended procedures by limiting staff access and taking precautions when entering and exiting the bird area.

Respecting the continuation of the bird area, Ms. Coulter advised that in 2023, the City will be reviewing and updating the Harrison Park Master Plan. The future of the bird area will be included in the review of this master plan.

#### 17. DISCUSSION OF ADDITIONAL BUSINESS

## 17.a Local Tribute

Councillor Koepke advised that she recently attended a tribute to celebrate the life of former Bruce-Grey-Owen Sound MPP Bill Murdoch. Councillor Koepke noted that many people were in attendance, including local musical artists providing entertainment. Councillor Koepke thanked Mayor Boddy for the kind words that he shared about Bill Murdoch during the tribute.

Councillor Koepke advised that proceeds from the event are being provided to the Bruce Grey Country Music Hall of Fame.

17.b Homelessness, Fire Department Negotiations Update, Poutine Fest, and Wedding Services

Councillor Tamming advised that homelessness is something that is addressed through the County of Grey using funds received from Grey County's member municipalities. In Grey County, Councillor Tamming noted that those experiencing homelessness tend to find themselves in either Hanover or Owen Sound. These communities must then work with the County to address and take action on the issue.

Councillor Tamming advised that negotiations with the Owen Sound Fire Department are ongoing. Councillor Tamming noted that the number of grievances filed by the Fire Department has gone down considerably over the past four years. This is due in part to the City's Human Resources division, and to the need and desire within the Fire Department to de-escalate situations as they arise to keep them from becoming formal grievances. Councillor Tamming advised that the City was successful at arbitration and was able to reduce the number of firefighters required at a fire call from five to four. This success does not reduce the total number of firefighters required under the collective agreement but does reduce the cost of overtime, thereby saving the taxpayer money. Councillor Tamming advised that the City is currently involved in arbitration with the Fire Department with the goal of reducing the total number of suppression firefighters that are required to be on staff as per the collective agreement. The arbitration is ongoing and has been delayed several times. A decision is anticipated to be released by summer 2023. If the City is successful in this arbitration it will save the taxpayer a considerable amount of money annually.

Councillor Tamming noted that he recently received a call from a resident advising that they enjoyed the Wiarton Poutine Fest.

Lastly, Councillor Tamming advised that his daughter was recently married at City Hall through the City's marriage service. Councillor Tamming commended the City's marriage services and thanked Lee-Anne Kazarian, Licencing and Marriage Coordinator for putting together a wonderful marriage ceremony.

## 17.c Mayor's Update

Mayor Boddy advised that September 30 is the National Day of Truth and Reconciliation and encouraged everyone to attend events that are taking place to listen, think, and reflect.

Mayor Boddy advised that 2022 Owen Sound Sports Hall of Fame Inductees dinner is taking place on September 30, 2022. Mayor Boddy noted that Director of Community Services, Pam Coulter is being inducted as a member of the Owen Sound 1996 Leon's Ladies Fastball Team.

Lastly, Mayor Boddy advised that this meeting will be Deputy Clerk Jamie Eckenswiller's last Council meeting with the City of Owen Sound. Mayor Boddy noted that Mr. Eckenswiller has accepted the position of Director of Legislative Services/Clerk with the Municipality of West Grey and wished him well in his new role.
