8.a Culture

8.a.1 Report AG-22-006 from the Director and Chief Curator of the Tom Thomson Art Gallery Re: Public Art Policy Funding Models

The Director and Chief Curator of the Tom Thomson Art Gallery provided an overview of the report respecting Public Art Policy Funding Models.

This included the following options for funding Public Art:

- Municipal Accommodation Tax (MAT);
- Development Charges (DCs);
- Community Benefit Charges (CBCs); and
- Capital Budget Allocation.

In response to a question from Committee, the Director and Chief Curator of the Tom Thomson Art Gallery noted that agreements would have to be evaluated individually to determine the plausibility of the City selling Public Art pieces to fund additional pieces.

The Director of Community Services confirmed that the Municipal Accommodation Tax Project, if approved, would only be available for the 2024 budget discussions.

8.b Grey County

8.b.1 Verbal Report from the Director of Economic Development, Tourism and Culture of Grey County

The Manager of Economic Development, Tourism and Culture for Grey County provided a verbal update.

The current focus is on Agri-Food opportunities including an OMAFRA meeting on September 29, 2022. The County's 2023 goals are to continue to focus on Agri-Food and investigate opportunities in the Clean Energy Sector with the Nuclear Innovation Institute and regional partners.

The Manager of Economic Development, Tourism and Culture of Grey County noted that the Federal Economic Development Agency (FedDev) is currently conducting research on rural innovation within Grey County. The County is one of six locations that were chosen across Canada.

It was further mentioned that the Economic Development Team will be relocated to Sydenham Campus along with the Grey Bruce Local Immigration Partnership staff.

Respecting tourism, a trailhead study is underway to identify appropriate infrastructure opportunities to enhance the resident and visitor experience. This includes a focus on areas that require improvements and new potential opportunities. Nineteen areas within the County are part of the study.
