By-law No. 2022-1XX

A By-law to appoint a member of Council to act in place of the Mayor during the absence of the Mayor and Deputy Mayor

WHEREAS section 242 of *The Municipal Act, 2001*, provides that a municipality may, by by-law, appoint a member of the council to act in the place of the head of council or other member of council designated to preside at meetings in the municipality's procedure by-law when the head of council or designated member is absent or refuses to act or the office is vacant, and while so acting such member has all the powers and duties of the head of council or designated member, as the case may be, with respect to the role of presiding at meetings; and

WHEREAS the Council of The Corporation of the City of Owen Sound (the "City") deems it necessary and expedient to appoint a member of Council to act in the place of the Mayor where the Mayor and Deputy Mayor are absent, refuse to act or the office is vacant, for the purpose of attending meetings, functions and other activities; and

WHEREAS on December 12, 2022, City Council passed a resolution directing staff to bring forward a by-law to appoint Council members as Acting Mayors as outlined in Staff Report CR-22-102;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF OWEN SOUND HEREBY ENACTS AS FOLLOWS:

- 1. Where the Mayor is absent or refuses to act or the office of Mayor is vacant, the Deputy Mayor may act as the Mayor and while so acting, has all the powers and duties of the Mayor.
- Where the Mayor and Deputy Mayor are absent or refuse to act, or the office of Mayor and Deputy Mayor are vacant, the following members of Council are appointed to act as Mayor during the time indicated next to their name, and while acting as Mayor, the Councillor shall have all the powers and duties of the Mayor and shall be referred to as the "Acting Mayor":
