8. PUBLIC MEETINGS

8.a Zoning By-law Amendment (ZBA) No. 41 - Housekeeping (Additional Residential Units)

Mayor Boddy declared the Public Meeting open at 7:06 p.m. and read the following announcement:

- Every person who attends a statutory public meeting required under the Planning Act shall be given an opportunity to make representations in respect of the proposed by-law.
- All submission materials for this application are available on the City's website and at the Planning Division, City Hall during regular business hours.
- If a person or public body would otherwise have an ability to appeal the
 decision of the City of Owen Sound to the Ontario Land Tribunal but the
 person or public body does not make oral submissions at a public meeting

or make written submissions to the City of Owen Sound before the Zoning By-law Amendment is passed, the person or public body is not entitled to appeal the decision.

 If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Owen Sound before the Zoning By-law Amendment is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

The City Clerk explained that notice of the Public Meeting was posted on the subject property, circulated to the prescribed persons and bodies, and placed on the City's website on December 16, 2022.

The City Clerk advised that personal information is collected under the authority of the *Planning Act* and the *Municipal Act*, 2001, and that the information collected will be used to complete the Zoning By-law Amendment process and will form part of the public record. Questions about this collection should be addressed to the City Clerk.

The City Clerk advised that any person wishing to receive notice of this decision of the Corporation of the City of Owen Sound on the proposed Zoning By-law Amendment application must make a written request to the City of Owen Sound.

Aleah Clarke of MHBC Planning provided a presentation on Zoning By-law Amendment (ZBA) No. 41 put forward by the City of Owen Sound to implement the City's 2021 Official Plan which increased the permissions for additional residential units (ARUs) and encourages the provision of affordable housing. The ZBA is City-wide and will affect all zones where street fronting low-density residential uses are permitted. Section 35.1 of the *Planning Act* directs municipalities to include regulations in zoning by-laws to permit ARUs and can permit up to two (2) ARUs on low-density street residential building types or an accessory structure. Amendment No. 11 to the County of Grey Official Plan was passed by County Council in 2022 and introduced new flexibility for the provision of ARUs and Tiny Homes and permits the use of two (2) ARUs per low-density street fronting properties, including permission for ARUs in accessory buildings.

Ms. Clarke advised that the City's 2021 Official Plan outlines the defining features of ARUs which include that they are a separate self-contained dwelling unit contained in single-detached, semi-detached or row house dwelling units or associated ancillary buildings, a maximum of two (2) ARUs are permitted per lot, all Zoning, Ontario Building Code, Ontario Fire Code, and Property Standards By-law regulations must be satisfied, on-site parking is required, and the outward appearance of the principle dwelling must not change. The proposed Zoning By-law Amendment would permit ARUs in any zone where a single detached, semi-detached or townhouse is permitted, a maximum of two (2) ARUs per lot and a maximum of 1 ARU permitted in an accessory building, one (1) parking space required per ARU, but this parking does not need to be independently accessible at all times, and a building permit will be required.

Ms. Clarke highlighted the ZBA process to date and advised that a recommendation report is tentatively scheduled to be presented to Council in February 2023 with the enacting by-law being presented to Council at a subsequent meeting.

Linda Montgomery, Owen Sound resident inquired if the ARUs will be designated to be long-term residences or will they be able to become short-term rental accommodations. The Director of Community Services advised that Council will be considering licensing around short-term rental accommodations later this year. This proposed Zoning By-law Amendment is consistent with the Provincial Policy Statement and the changes to the *Planning Act* under Bill 23. The ARUs

could become short-term rental accommodations but would be subject to the rules that Council puts into place going forward around licensing of short-term rentals.

In response to a question of Council, Ms. Clarke explained that if municipal servicing is not available for the ARU, then adequate servicing (such as a septic system) could be permitted if it receives approval from the designated authorities. For example, environmental approval for the expansion of a septic system or proof that the septic system would be large enough to accommodate the additional unit.

In response to a question of Council, the Director of Corporate Services advised that upon the City issuing a building permit, it triggers the Municipal Property Assessment Corporation (MPAC) to look at the property and if there is a change in value, MPAC would capture this at the time that occupancy is granted by the City's Building Division.

In response to a question of Council regarding the reduction of the requirement to have one (1) parking space per ARU, the Director of Community Services noted that this can be considered as part of the recommendation report that will come forward to Council at a future meeting. The City's 2021 Official Plan does contemplate a parking space to be provided for each of the ARUs. Staff are proposing that the parking spaces not be independently accessible so they could be parked in tandem. Ms. Clarke advised that the *Planning Act* was recently amended to permit reducing the one (1) parking space per ARU and other municipalities have already proposed this.

There being no other comments, Mayor Boddy declared the Public Meeting closed at 7:22 p.m.

The Manager of Planning and Heritage provided a presentation on Zoning By-law Amendment (ZBA) No. 43 put forward by Ron Davidson Land Use Planning on behalf of Andpet Realty Limited for an indoor storage facility with ten (10) buildings at 1730 27th Avenue East. Ms. Robart highlighted the location of the subject lands, noting that the lands are currently vacant with an Employment designation in the City's Official Plan. The lands are zoned as Heavy Industrial (M2), General Industrial (M1), and Hazard Lands (ZH) in the City's Zoning Bylaw.

Ms. Robart highlighted the ZBA process to date and advised that a recommendation report is tentatively scheduled to be presented to Council on January 30, 2023, with the enacting by-law being presented to Council on February 13, 2023.

No members of the public were present to speak in support of or opposition to the application.

There being no comments, Mayor Boddy declared the Public Meeting closed at 7:31 p.m.

9. DEPUTATIONS AND PRESENTATIONS

9.a Deputation from Vivian McCaffrey, SweetWater Music Festival Board Chair Re: 2023 SweetWater Music Festival

Vivian McCaffrey, Chair of the Board of the SweetWater Music Festival provided a deputation to Council requesting financial support from the City and expanded support on marketing and promotion for the 2023 SweetWater Music Festival. Ms. McCaffrey provided some background information on the festival and advised that SweetWater will be celebrating its 20th anniversary in September 2023. SweetWater not only offers music performances, but also promotes aspiring young artists through its Next Wave program, supports music education through its contact with the schools, and stages a String Instrument Showcase annually to highlight local luthiers as well as luthiers from across Canada.

Ms. McCaffrey noted that the festival aligns with the City of Owen Sound's Strategic Plan through the pillars of society and culture and economy. SweetWater contributes to the City's growing reputation as an important arts community, one that attracts arts patrons to visit and that draws artists of various disciplines to live in the community. Audience members and visiting musicians patronize local restaurants and businesses, the musicians are housed in the River District or in local hotels, the festival rents local venues and hires local photographers and sound and recording professionals, and the festival orders meals for the musicians from local caterers and provides opportunities for local vendors to sell food and beverages at its outdoor venues.

Ms. McCaffrey advised that SweetWater is seeking \$3,500 from the City to support the production of a documentary film to celebrate this unique local arts organization and assist in running the 20th anniversary festival, as well as expanded promotion and marketing support from City staff. For the past few years, SweetWater has received modest funding from the Municipality of Meaford for performances that take place in that community. Ms. McCaffrey noted the current Artistic Director, Edwin Huizinga, is planning to add one or two free concerts to the festival program this Fall and that perhaps the City would be interested in sponsoring one of these concerts as another option to support the SweetWater Music Festival.

In response to a question of Council, Ms. McCaffrey advised that over a four-year period, the Municipality of Meaford provided approximately \$7,500 in financial support. This financial support ended in 2022 so the Board will be going back to the Municipality of Meaford to request their continued financial support. Production of the video will cost approximately \$20,000 and they will be doing additional fundraising for this full amount through their long-term supporters and corporate and business partners within the City. If the City were to provide financial support for the video, credit would be given on the video. If the City were to sponsor one of the concerts, credit would be given on the program and at the concert. The festival is open to working with the City on what sort of recognition it would like to receive if Council wishes to support them.

In response to a question of Council, the Director of Corporate Services advised that currently there is no money in the budget to support these types of requests so if approved by Council, this would be an increase to the overall budget. If Council wishes, this request could be discussed at the upcoming budget meetings in February.

It was noted by Council that the City has a policy which states that the City does not provide grants and that organizations be directed to the Community Foundation Grey Bruce for financial support. Council suggested that the festival could approach the River District Board of Management on a potential partnership as well as the Chamber of Commerce to ensure that they are connecting with the entire business community in finding a community sponsor.

Councillor Farmer advised that the PowerPoint presentations from the Council orientation sessions on December 2 and 9, 2022 are now publicly available on the City's website.

Councillor Farmer noted that in July 2022, the previous Council sent a letter to the province and other municipalities highlighting that it is problematic that there is no mechanism to remove elected municipal officials when they have breached workplace violence and harassment policies. Bill 5 is currently before the provincial legislature and moves to second reading in May. It would give integrity commissioners the ability to remove elected officials if a judge has recognized an egregious breach of workplace violence and harassment policies.

17.d Mayor's Update

Mayor Boddy advised that he recently attend the Clean Energy Frontier Summit hosted by Bruce Power, the Nuclear Innovation Institute, and Bruce County. The keynote speaker was Brock Dickinson and he talked about world demographics and the change going over the next number of years and how it will affect economic development in North America and around the world. Mike Rencheck, President and CEO of Bruce Power, and Mike Comello of Catapult Grey Bruce also spoke at the summit.

Mayor Boddy noted that he attended the Strathcona Cup this past weekend at the Blue Water Curling Club. This event is 120 years old and every five years, a team from Canada goes to Scotland or a team from Scotland comes to Canada. The Scottish curlers were split into three concurrent tours of Canada - Central, East, and West. The Strathcona Cup was donated by Sir Donald Smith, the 1st Baron Strathcona and Mount Royal.

Mayor Boddy advised that on Saturday, January 28, Grey Roots will be hosting the Grey Bruce Lunar New Year Celebration and the Alzheimer Society is hosting the first annual SOUP's On at the Bayshore Community Centre.

Mayor Boddy advised that he and Deputy Mayor Greig will be attending the ROMA (Rural Ontario Municipal Association) Conference from January 22 - 24. The City applied for a delegation with the Minister of Health at ROMA and have been granted the opportunity to meet with her to discuss physician recruitment. They will provide an update to Council following this delegation.
