1. CALL TO ORDER

The City Manager called the meeting to order at 5:30 p.m.

2. ELECTION OF CHAIR AND VICE CHAIR

The City Manager welcomed Committee members and held introductions. The City Manager opened the floor for nominations for the position of Chair for the Operations Committee.

Councillor Koepke nominated Deputy Mayor Greig for the position of Chair. Deputy Mayor Greig accepted the nomination. The City Manager asked for any further

nominations. There being no further nominations, the City Manager declared nominations closed. Deputy Mayor Greig was acclaimed as Chair of the Operations Committee and assumed the position of Chair.

Councillor Koepke accepted the nomination. Chair Greig asked for any further nominations. There being no further nominations, Chair Greig declared nominations closed. Councillor Koepke was acclaimed as Vice Chair of the Operations Committee.

6. DEPUTATIONS AND PRESENTATIONS

6.a Presentation from Director of Public Works and Engineering Re: Operations Committee Introduction 2023

The Director of Public Works provided a PowerPoint presentation outlining the key projects and tasks of the Operations Department to the Committee.

Committee questioned whether there is a Feasibility Study or discussion about another bridge in Owen Sound. Staff explained that in the 2010 Transportation Master Plan, one objective was to consider other bridge locations in the City of Owen Sound. Staff also explained that adding an additional bridge would impact the roads network significantly especially on the east side. Staff are currently working to optimize existing infrastructure and the roads network through timing of traffic signals, turning lanes, and active transportation facilities.

6.b Deputation from Dillon Consulting Re: Waste Management Strategy Update

Alida Kusch, Dillon Consulting, provided an update to the Committee regarding the Waste Management Strategy.

Some of the options presented included the economic feasibility, social impact, and environmental impact of the following 16 options:

- 1. Green Bin Collection.
- 2. Backyard Compost Program.
- 3. Long-term operations at the City Compost Site.
- 4. Transition Plan for Individual Producer Responsibility.
- 5. Enhancing Service Levels such as weekly garbage collection.
- 6. Evaluate curbside service level options.
- 7. Enhance promotion of the goods exchange day.
- 8. Explore options for increasing the number of HSP Drop-off events.
- 9. Enhance public space container management and systems.
- 10. Develop a strategy for managing litter.
- 11. Develop a promotion and education strategy.
- 12. Update the solid waste by-laws.
- 13. Enhance enforcement mechanisms of the solid waste by-law.
- 14. Improve waste management services in the River District.
- 15. Explore opportunities with neighbouring Municipalities.
- 16. Establish climate change targets/policies for waste management.

Committee discussed:

- Projected household waste savings with a Green Bin implementation option;
- Current backyard composters;
- Non eligible sources and how that will impact the City of Owen Sound;
- Compost site and limiting it to just City of Owen Sound residents; and
- Goods exchange day and the remaining items at the end of the event.

- 2. Approve increasing the annual administration fee to participating municipalities using the Canada or Ontario CPI for 2020, 2021 and 2022, raising the annual administration fee from \$1,400 to \$1,565 in 2023; and

3. Direct staff to bring forward a by-law to execute the 2023 Hazardous and Special Products Agreements with Georgian Bluffs, Grey Highlands, Meaford and Chatsworth municipalities."
