Subject: Statement of 2022 Council Remuneration and Expenses

Recommendations:

THAT in consideration of Staff Report CR-23-030 respecting the Statement of 2022 Council Remuneration and Expenses, City Council receives the report for information purposes.

Highlights:

- Council members are allocated \$3,750 annually for expenses.
- The Mayor's conference expenses are not capped.
- Expenses can include conferences, travel, and promotional items.

Previous Report/Authority:

Municipal Act, 2001, section 284

Policy CrS-HR40

Background:

The *Municipal Act, 2001* requires municipal treasurers to submit to Council an itemized statement of remuneration and expenses paid to or on behalf of

each Council member and members of local boards. Specifically, section 284 (1) states that:

The treasurer of a municipality shall in each year on or before March 31 provide to the council of the municipality an itemized statement on remuneration and expenses paid in the previous year to,

- a) each member of council in respect of his or her services as a member of the council or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council;
- b) each member of council in respect of his or her services as an officer or employee of the municipality or other body described in clause (a); and
- c) each person, other than a member of council, appointed by the municipality to serve as a member of any body, including a local board, in respect of his or her services as a member of the body.

Analysis:

As detailed in Policy CrS-HR40, Council's Budget sets out the amount allocated to each member of Council annually for conferences, travel expenses, and promotional items. The annual allotment for each Council member is \$3,750.00; however, the Mayor's conference expenses are not capped.

The attachment provided shows the breakdown of salaries/per diems and expenses for each member of Council and Board members who have been appointed by Council. As 2022 was an election year, three members of Council are reported from January 1 – November 20, 2022, while the three new Council members are reported from November 21 – December 31, 2022.
