How does a fund work at CFGB?

- Donor's gift is pooled with other endowed assets, invested through careful stewardship and income is used to make grants
- CFGB promotes funds, offers online giving portal, receipts all incoming donations
- Recommend investment in the Regular pool of investment; \$5k to open a fund, pays out at \$25k; must be invested for one full fiscal year before payout
- CFGB charges a small admin fee at 1.5% of total fund value levied once a year
- Annual statements are issued to fund advisors (you can appoint up to 4) listing earnings, grants, transfers, balances
- CFGB invests with Jarislowsky Fraser since inception 6.6% annual return;
 F&I committee manages relationship with investment manager
- Board approves annual granting percentage (our average disbursement is regulated at 5%) some undistributed income can build in a fund as a cushion for bad market years
- Deadlines for granting for projects and programs are April 15 and September 15 -- we don't fund ongoing operational costs, but support projects, programs that bring sustainability and new services/programs into our communities.
- Capital funding deadline for letter of intent: July 1, up to \$35,000 available.

Does CFGB manage other funds supporting kids' access to sports?

- Ben Morris Memorial Fund: A memorial fund designated to support the Chatsworth Agricultural Society and Chatsworth Minor Sports
- Clarence "Flea" & Marjorie Christie Endowed Fund: To support kids access to minor hockey
- Grey Granite Curling Club Endowed Fund: Supports youth & sport initiatives in Owen Sound, Georgian Bluffs, Chatsworth
- Jordan Fawcett Memorial Endowed Fund: Sponsors two basketball athletes from Grey Highlands Secondary School to Celtic Sports Camp, and support sports related projects within the community
- Noble Family Endowed Fund: Created by Percy & Kathleen Noble in 1995, grants are directed to support minor sports for boys and girls in the smaller communities outside of Owen Sound with priority to Shallow Lake, Hepworth, Allenford and Southampton

- Established in 1994, by community volunteers, coming up to 30th anniversary; CFGB has granted every year since inception

- CFGB manages more than 180 endowed funds, covering education, arts and culture, health care, environment, poverty reduction, recreation and more.
- CFGB manages six active community funds: Owen Sound, Meaford, Grey Highlands, Saugeen Shores, Kincardine, and Southgate ensuring a perpetual revenue stream for grant applications that come in from these geographic areas, specifically
- CFGB cannot fund individuals* but does grant to "qualified donees" as defined by Income Tax Act of Canada - municipalities, registered schools, both local First Nation Territories, other charities.
- Non-profits can be sponsored by any of these qualified donees to seek funding from a grant application
- CFGB is a convenor of discussion and a knowledge-gatherer, through Vital Signs reports -- a check up on the vitality and health of Grey Bruce in a readable, accessible, engaging format
