Kelso Beach at Nawash Park Master Plan

City Council approved a new Kelso Beach at Nawash Park Master Plan in February 2023 via the minutes of the January 25 Community Services Committee; CS-230125-006

"THAT the minutes of the Community Services Committee meeting held on January 25, 2023 be received and the recommendations contained therein be approved."

The Kelso Beach at Nawash Park Master Plan included recommendation 5.1.2 Update the official name of the Park to Kelso Beach at Nawash Park stating:

The City adopted the practice of referring to the subject property as Kelso Beach at Nawash Park in 2018, however the park has never officially been re-named to the preferred nomenclature, and it is still legally registered as Kelso Beach Park.

In 2021 the City adopted Policy CS087 – Naming and Re-Naming Policy for City Parks and Facilities.

A key objective of the City's strategic plan is supporting inclusivity, diversity and accountability in the community and this is reflected in the policy.

It is recommended that the City bring forward a request to the City Clerk to officially rename and legally register the property as Kelso Beach at Nawash Park.
