1. CALL TO ORDER

Chair Dodd called the meeting to order at 5:31 p.m.

8. REPORTS OF CITY STAFF

8.a Planning and Heritage

Committee discussed item 12.a during the discussion of Item 8.a.1.

8.a.1 Report CS-23-043 from the Junior Planner Re: Community Garden Updated Policy and Draft License Agreement

The Junior Planner provided an overview of the report respecting the Community Gardens Updated Draft Policy and Draft License Agreement and included an overview of the feedback from OurCity and the Community Services Committee. Additionally, a review of the final policy was provided.

Chair Dodd noted appreciation for the significant work completed by staff and Committee members.

In addition to the report, the Director of Community Services noted that a letter has been submitted from Jacquie Furtner on behalf of the Parkview subdivision neighbourhood respecting a request to add Parkview Park to the list of permitted Community Garden locations. This included a circulation letter that was provided to residents within the Parkview neighbourhood and residents abutting the park on 7th Avenue East. It was noted that the park does meet the locational criteria for a Community Garden, and staff are recommending that the park could be included as an eighth park.

In response to a question from Committee, the Junior Planner noted that the Community Improvement Plan – Landscaping and Property Improvement Grant has been amended to include water costs only and does not include materials. Committee noted that Community Foundation Grey Bruce, Trillium Foundation and the New Horizons for Seniors Program could support grant applications for community gardens.

Committee recommended that a communication plan be in place to ensure that the public is adequately informed. Committee inquired about the opportunity for an open-house forum and further noted that City communication should be required before the addition of Parkview Park to ensure transparency.

The City Manager advised that the OurCity platform includes current and previous projects for viewing.

In response to a question from Committee, the Junior Planner advised that St. George's Park is the only park with water services that existed before the development of the community garden. It was further noted that water service is available at many park locations. Water access is optional as additional choices exist, such as rain barrels, cisterns or storage containers.

"THAT in consideration of Staff Report CS-23-043 respecting Community Gardens – Updated Draft Policy and Draft License Agreement, the Community Services Committee, in considering the reports, public feedback, and agency and staff input, recommends that City Council:

- 1. Finds that the updated policy is consistent with the Provincial Policy Statement and conforms to the County of Grey and City of Owen Sound Official Plans and City Zoning By-law (2010-078, as amended);
- 2. Finds that the public engagement feedback respecting community gardens has been sufficiently incorporated into the policy;
- 3. Directs staff to bring forward a by-law to approve the updated Community Gardens Policy, including Parkview Park, notwithstanding Clauses 25 and 26 of the policy subject to a circulation of notice to residents within 100m surrounding the proposed Community Garden location;
- 4. Approves an amendment to the Property & Landscaping Improvement Grant Program Guidelines to include a

Community Garden located on City property with an approved Agreement that meets the requirements of the Policy and has an executed agreement (maximum one grant per year, maximum grant 50% up to a maximum of \$5000 relating to the provision of water);

- 5. Approves the Draft Licence Agreement, subject to review by the City Solicitor;
- 6. Directs staff to bring forward a by-law to amend the Delegation of Powers and Duties By-law No. 2014-109 to delegate approval authority for:
 - a. Community Garden Applications to the Director of Community Services and City Manager, acting jointly, provided that the application is consistent with the Community Gardens Policy; and
 - b. The execution of Community Garden Agreements to the Director of Community Services and City Manager, acting jointly, provided that the Community Garden Application has been approved."

- 8.b Community and Business Development
 - 8.b.1 Report CS-23-038 from the Events and Activation Coordinator Re: 2023 Summer Events

The Events and Activation Coordinator provided an overview of the report respecting 2023 Summer Events.

The upcoming events that were highlighted include the following:

- Music at the Market Concert Series:
- TD Harbour Nights Concert Series;
- Outdoor Movie Nights; and
- The Waterfront Festival.

Staff noted several changes to the event schedule to ensure meeting accessibility needs and inclusivity.

In response to a question from Committee, the Events and Activation Coordinator noted that the retirement residences and local partners are included in the poster and media advisory distribution lists. Staff advised that the City has successfully received a \$12,000 Celebrate Canada Grant that will be utilized towards the 2023 Waterfront Festival.

8.c Parks and Open Space

8.c.1 Report CS-23-041 from the Manager of Parks and Open Space Re:
Harrison Park Pool Operating 2023 Memorandum of Understanding and
Fees Update

The Manager of Parks and Open Space provided an overview of the report respecting Harrison Park Pool Fees.

The report included recommended increases for Harrison Park Pool fees for day passes, season passes and private pool rentals. Additional revenue is required to maintain the City's cost of operating the Harrison Park Pool at a reasonable level. It was noted that as part of the Harrison Park Master Plan process, staff recommend evaluating the pool operation and including evidence-based recommendations for delivering outdoor swimming at Harrison Park.

The Director of Community Services advised that sponsored swims still allow for complimentary offerings. Additionally, Bruce Grey Child and Family Services and the Owen Sound and North Grey Public Library receive passes that can be borrowed for other swim times.

In response to a question from Committee, the Manager of Parks and Open Space noted that private rentals for the pool are booked through the YMCA based on inquiries and would be based outside of the proposed swimming schedule. Staff will work to promote the opportunity to rent the pool through social media and the website.

- 3. Execute the proposed Memorandum of Understanding with the YMCA of Owen Sound Grey Bruce (the "Y") for the 2023 outdoor swimming season; and
- 4. Review different operating model options for the 2024 swimming season via the Harrison Park Master Plan process that is currently underway."

8.c.2 Report CS-23-040 from the Manager of Parks and Open Space Re: Renaming of Kelso Beach Park to Kelso Beach at Nawash Park

The Manager of Parks and Open Space provided an overview of the report respecting the renaming of Kelso Beach Park to Kelso Beach at Nawash Park.

In December 2021, Council approved Policy CS-087, Naming and Re-Naming a City Park. Based on the Master Plan consultation and recommendation, an application to rename Kelso Beach Park, Kelso Beach at Nawash Park, was submitted to the City Clerk. The application has been deemed complete. It was noted that the next steps are for Community Servies Committee to appoint a working group by resolution composed of 3 members of Council, the City Manager or delegate, Manager of Parks and Open Space and the Manager of Human Resources.

Chair Dodd opened the floor for nominations for Councillor appointment to the working group. Member Walker nominated Councillor Farmer.

Councillor Farmer accepted the nomination. Member Kemick nominated Chair Dodd. Chair Dodd accepted the nomination. Chair Dodd nominated Vice Chair Kukjera. Vice Chair Kukjera accepted the nomination.

Councillor Farmer, Chair Dodd and Vice Chair Kukreja were acclaimed as the three members of Council to be included in the working group.

In response to a question from Committee, the Manager of Parks and Open Space advised that the request for name change was in response to community feedback. The Director of Community Services further mentioned that the Parks, Recreation and Facilities Master Plan also refers to the park as Kelso Beach at Nawash Park.
