Subject: Appointment to the Owen Sound Municipal Non-Profit

Housing Corporation and Owen Sound Housing Company

Recommendations:

THAT in consideration of Staff Report CR-23-050 respecting Appointment to the Owen Sound Municipal Non-Profit Housing Corporation and Owen Sound Housing Company Boards, City Council directs staff to bring forward a by-law to amend the Board and Committee By-law to appoint Selwyn Hicks to the Owen Sound Municipal Non-Profit Housing Corporation and Owen Sound Housing Company Boards with a term beginning immediately and ending on January 31, 2025.

Highlights:

- The Owen Sound Municipal Non-Profit Housing Corporation (OSMNPHC) and the Owen Sound Housing Company (OSHC) are corporations established by Letters Patent, with a joint board.
- The OSMNPHC and OSHC provide and operate housing accommodation primarily for persons of low or modest income at rentals below the median current rental market.

Previous Report/Authority:

By-law No. 2023-010 - Board and Committee By-law

Background:

Annually, the OSMNPHC and OSHC make recommendations to Council with members they would like appointed. The OSMNPHC and OSHC have the same membership, so a board member is appointed to both boards simultaneously.

At the time the 2023 Board and Committee By-law was passed, there were no vacancies on the OSMNPHC and OSHC Boards. On April 19, 2023, the Executive Director of the OSMNPHC and OSHC notified staff that a Board member had resigned, thus creating a vacancy.

Analysis:

During the May 8, 2023 Closed Session, City Council directed staff to bring forward an open report to appoint Selwyn Hicks to the OSMNPHC and OSHC Boards with a term ending January 31, 2025.

The by-law to amend the Board and Committee By-law is being presented concurrently with the staff report to have Mr. Hicks appointed prior to the Board's next meeting.

Financial Implications:

There are no financial implications associated with this report.

The Executive Director of the OSMNPHC and OSHC will be informed of the appointment.
