1. CALL TO ORDER

Chair Dodd called the meeting to order at 5:31 p.m. All members and staff noted above were present except for Member Dantas.

2. CALL FOR ADDITIONAL BUSINESS

There was no additional business.

4. CONFIRMATION OF MINUTES

4.a Minutes of the Community Services Committee meeting held on April 19, 2023

- 8.a Parks and Open Space
 - 8.a.1 Report CS-23-052 from the Manager of Parks and Open Space Re: Kelso Beach at Nawash Park Re-Naming Working Group Recommendation

The Manager of Parks and Open Space provided an overview of the report respecting Kelso Beach at Nawash Park Re-Naming.

Member Dantas joined the meeting at 5:34 p.m.

The working group, consisting of three members of Council, the City Manager, Manager of Human Resources, and Manager of Parks and Open Space met on May 4, 2023 to consider the request. The working group reviewed the request, policy background, history of the park, previous reports, and Policy CS87.

Pending approval of the recommendation by Council, a by-law will be submitted for approval to re-name Kelso Beach Park to Kelso Beach at Nawash Park. The re-naming would trigger:

- Updating the name of the park in the Parks By-law through an amendment;
- References on the City's website would be reviewed to ensure they align with the re-naming, and updated as required;
- Municipal addressing and land registry will be updated;
- Transport Canada leases will be updated upon renewal; and

 The City would encourage all users and special event promoters to use the new name in their documents and event promotions.

8.b Planning and Heritage

8.b.1 Report CS-23-053 from the Manager of Planning and Heritage Re: Provincial Policy Statement 2023 Review

The Manager of Planning and Heritage provided an overview of the report respecting the Proposed Bill 97 and Provincial Policy Statement (PPS). Bill 97, *Helping Homebuyers, Protecting Tenants Act* proposes several amendments to the land-use planning legislation including proposed changes to the *Planning Act* and *Development Charges Act*. The Province has also released a new Provincial Planning Statement, which combines the Provincial Policy Statement, 2020 and: "A Place to Grow: Growth Plan for the Greater Golden Horseshoe, 2022", into a single document.

The Manager of Planning and Heritage provided an overview of the potential impacts of the proposed changes of both Bill 97 and the PPS to the City.

Staff summarized the changes to Bill 97 which include:

- Updates to the implementation of timeframes for planning applications;
- Updates to "area of employment";
- Clarification to parking associated with Additional Residential Units (ARUs);
- Exempting Minister's Zoning Orders (MZOs) from being consistent with the PPS or local Official Plans; and
- Modifying with respect to ARUs the definition of "parcel of urban residential land" to "parcel of land".

Staff encourages the Province to consider, where there is mutual agreement of the parties, to pause timelines to allow work toward a collaborative solution. Staff are very cautious about the new provisions for MZOs.

Changes to the PPS are proposed to:

- 1. Growth targets, allocations, and planning horizon
- 2. Affordable housing and coordination
- 3. Employment land conversions
- 4. Climate change
- 5. Servicing
- 6. Natural heritage policies not included in the current draft
- 7. Implementation and updated definitions

Concerns were noted by staff respecting several of these proposed changes, in particular respecting:

- Intensification and growth outside serviced settlement areas;
- The removal of the definition of affordable housing and weakening of policies;
- ARUs in areas outside of urban areas;
- New lot creation policies that will see broad permissions for lot creation that will have significant and long-term impacts on the environment, agriculture operations and the role of urban settlement areas;
- Employment land conversions, noting there is a limited supply of serviced empty lands, and these are important to the long-term financial sustainability of communities;
- Significant changes for servicing (water and sewer) policies;
- Weakening of policies that support addressing impacts of climate change including removal of stormwater policy; and
- Natural heritage policies are "missing" in the draft.

In response to a question from Committee, the Director of Community Services advised that Grey County's meeting with all lower-tier municipal planners was encouraging as it emphasized that all the communities and County had significant concerns. Copies of the County reports were provided to staff and Committee to review.

It was further noted that the proposed changes differ significantly from the current policy and Committee reiterated the hope that City comments will be reviewed and considered.

In response to a question from Committee regarding ensuring the City's comments are heard, the Director of Community Services advised that Committee could request a meeting with MPP Byers together with Grey County staff to reiterate the concerns with the proposed changes.

- 2. Indicate support for comments made through County of Grey reports PDR-PEDAC-19-23 and PDR-AAC-20-23;
- 3. Forward the report to the Standing Committee on Heritage, Infrastructure and Cultural Policy as the City's comment;
- 4. Provide a copy of the report to Rick Byers, M.P.P.; and
- 5. Request a meeting with Rick Byers, M.P.P. and Grey County staff to discuss the proposed changes."
