Subject: Public Appointment and Vacancy - Tom Thomson Art

Gallery Advisory and Operations Committees

Recommendations:

THAT in consideration of Staff Report CR-23-061 respecting Public Appointment and Vacancy - Tom Thomson Art Gallery Advisory and Operations Committees, City Council directs staff to bring forward a by-law to amend the Board and Committee By-law to:

- 1. Remove Constance Maconaghie from the Tom Thomson Art Gallery Advisory Committee (TTAGAC) and appoint Sarah Goldrup to the TTAGAC with a term beginning immediately and ending on January 31, 2027; and
- 2. Remove Lauren Donkersgoed from the Operations Committee and note a vacancy with a term ending on January 31, 2026.

Highlights:

- Staff have received resignations for both the TTAGAC and Operations Committee.
- On May 29, 2023, Council directed staff to bring forward an open report to appoint Sarah Goldrup to the TTAGAC.
- This appointment will give the TTAGAC a full complement of members prior to the next regularly scheduled meeting.

• Direction from Council is required to amend the Board and Committee By-law to appoint Sarah Goldrup and to reflect the vacancy on the Operations Committee.

Closed Staff Report CR-23-054 – Public Member Appointments to Operations and Tom Thomson Art Gallery Advisory Committees.

Background:

At the time the 2023 Board and Committee By-law was passed, there were no vacancies on the TTAGAC or Operations Committee. Since its passing, a vacancy has arisen on each committee.

Analysis:

During the May 29, 2023, Closed Session, City Council directed staff to bring forward an open report to appoint Sarah Goldrup to the TTAGAC with a term ending January 31, 2027.

The City's Board and Committee By-law provides that one member of the TTAGAC be a self-declared artist. The appointment of Ms. Goldrup will satisfy this requirement.

Due to a resignation on the Operations Committee, the Board and Committee By-law needs to be amended to reflect this vacancy with a term ending on January 31, 2026. Staff will be seeking direction from Council on this vacancy in closed session.

The by-law to amend the Board and Committee By-law is being presented concurrently with the staff report to have Ms. Goldrup appointed prior to the next TTAGAC meeting.

Financial Implications:

There are no financial implications associated with this report.

The TTAGAC recording secretary will be advised of the appointment and will send out the meeting invitations to Ms. Goldrup.
