The strategic plan as it applies to the corporation represents only 2% of emissions for the city. 98% is residential. The date for Net-Zero for both the corporation and the city are both set at 2050. This does not seem feasible for the residential target without strong city initiatives in that direction. Aggressive initiative could include: City mandated EV car charging points. Incentives to big box stores in install them for tax consideration, and prominent mentions in city climate mitigation promotions by the city Tax incentives for householders to install charging points in their homes, and mandatory for all new builds. Incentives for motor vehicle incentive to stock and sell electric vehicles, and penalties for those that don't EV designated parking spots in Owen Sound Initiative to fill all stores in downtown Owen Sound, particularly with food stores. There is ample parking in downtown, and it is very walkable from an extensive area of residential areas. Encouraging residents to shop locally in downtown will reduce driving to the hill tops on each side of the city for basic purchases. Increased property taxes could be levied on unfilled stores after a period of vacancy. Legatts Furniture Store has been empty for years, and is a significant block to making the area a vibrant shopping and living area. Make 2nd Avenue E from 11 St W to 8 th St a pedestrian area Make the process of establishing of community gardens less onerous. I was part of a community garden initiative in the "Charlie Parkette" on 2nd Ave E and 6th St. We were stonewalled by the city over concerns about soil contamination, although that was not made explicit, just implicit. Rather than meeting with us to discuss options to create a safe garden, such as raised beds we received a very condescending letter from a city lawyer (copy can be supplied) and all our hard work was destroyed. It is part of the city climate initiative to encourage community gardens but we were treated very

poorly and our efforts certainly not valued. The parkette has been abandoned by the city and is a waste land that no one uses, except probably drug dealers, and has recently been sprayed to kill the dandelions who grew out of the wood chips. It is an eye sore. Dandelions are an important source of nectar for early hatching insects and it is beneficial if they are allowed to thrive. Interestingly, the parkette was formerly used as a play ground by the childcare that used to be located at the YMCA but no issues of soil contamination were raised then, and now it is a wasteland.
