6. PUBLIC MEETINGS

6.a Zoning By-law Amendment No. 50 - 1580 20th Street East (Wakeford)

Mayor Boddy declared the Public Meeting open at 5:33 p.m. and read the following announcement:

- Every person who attends a statutory public meeting required under the Planning Act shall be given an opportunity to make representations in respect of the proposed by-law.
- All submission materials for this application are available on the City's website and at the Planning Division, City Hall during regular business hours.
- If a person or public body would otherwise have an ability to appeal the decision of the Council of The Corporation of the City of Owen Sound to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to The Corporation of the City of Owen Sound before the Zoning By-law Amendment is passed, the person or public body is not entitled to appeal the decision.
- If a person or public body does not make oral submissions at a public meeting or make written submissions to The Corporation of the City of Owen Sound before the Zoning By-law Amendment is passed, the person or public body may not be added as a party to the hearing of an appeal

before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

The City Clerk explained that notice of the Public Meeting was posted on the subject property, circulated to the prescribed persons and bodies, and placed on the City's website on July 4, 2023. All comments received prior to the agenda being published were attached to the agenda. Two comments were received after the publication of the agenda and will be added to the agenda when it is republished. The City Clerk encouraged those present for the public meeting to sign the sign-in sheet located on the table outside of Council Chambers.

The City Clerk advised that personal information is collected under the authority of the *Planning Act*, and that the information collected will be used to complete the Zoning By-law Amendment process and will form part of the public record. Questions about this collection should be addressed to the City Clerk.

The City Clerk advised that any person wishing to receive notice of the decision of The Corporation of the City of Owen Sound on the proposed Zoning By-law Amendment application must make a written request to the City of Owen Sound.

The Manager of Planning and Heritage provided a presentation on Zoning By-law Amendment (ZBA) No. 50 put forward by Albert Wakeford on behalf of 845377 Ontario Limited for a rock-climbing bouldering gym in the existing Industrial Mall located at 1580 20th Street East. Ms. Robart highlighted the location of the subject lands, noting that the lands are designated Employment and Hazard Lands in the City's Official Plan. The lands are zoned as Heavy Industrial (M2) and Hazard Lands (ZH) in the City's Zoning By-law.

Ms. Robart highlighted the ZBA process to date and advised that a recommendation report and enacting by-law are scheduled to be presented to Council on September 11, 2023.

Applicant, Bert Wakeford, noted that the ZBA is good for Owen Sound, both in the short-term and long-term, as it will allow the City to add a rock climbing gym to its attractions, create additional employment, and provide a natural separation between the nearby residential areas to the west and the heavy industrial areas to the east. Mr. Wakeford advised that the ZBA is consistent with the surrounding zoning designations to the north, west and south, and is an appropriate use for the existing Industrial Mall.

Mr. Wakeford noted that one comment was received in opposition to the ZBA and this individual suggested that the property be rezoned to MU (Mixed Use Commercial) instead of M1 as it is a more appropriate use. Mr. Wakeford advised that his building is an industrial mall and this is not a permitted use within the MU zone. Additionally, the property located to the south is zoned M1 and an MU designation would be inconsistent with the surrounding properties. Permitted uses within the MU zone include a retail store, restaurants, hotels, and heavy industrial. Rezoning his property to MU would continue to allow heavy industrial uses and defeat the purpose of the separations from the residential areas to the west. In closing, Mr. Wakeford noted that the MU zoning is incongruent with his building, contrary to an industrial mall, and out of step with prudent urban planning.

Mayor Boddy invited members of the public to ask questions or provide comments on the ZBA.

Tyler Stoddart, Owen Sound resident, spoke in favour of the ZBA application, highlighting that there is a need for this type of facility within the City and it would help bring people together.

Carlin Val, Owen Sound resident, spoke in favour of the ZBA application, noting that he operates At Last Adventures and At Last Forest Schools. Mr. Val advised that he is passionate about bringing opportunities to the community and believes

that a climbing gym can do great things for the City and provide recreational options during the winter months, as well as throughout the rest of the year.

Sam Kessaram, Owen Sound resident, spoke in favour of the ZBA application, noting that he moved to the City two years ago and is an avid rock climber. Currently, he has to travel quite a distance to go to a rock-climbing gym or an outdoor location. Mr. Kessaram believes that this facility would provide numerous benefits to the community, bring revenue to the area, and allow new residents to integrate into the community.

Kat Scott, Owen Sound resident, spoke in favour of the ZBA application, noting that she moved to the City one year ago because of the close access to the outdoors. She indicated that there is something special about being able to get outside and participate in various types of activities. Indoor facilities create that next step, such as building physical strength, new relationships, and new skills.

Courtney Fernandez, Town of Saugeen Shores resident, spoke in favour of the ZBA application, noting that many of her friends who live in Port Elgin would love to have this type of facility in Owen Sound as they currently need to travel over an hour to an indoor climbing gym in Goderich.

Mr. Val spoke again to inform Council that he is the individual who is trying to start this business and has been looking for a suitable location for over four years. He is looking to build a community and rock climbing is a healthy exercise for mental health.

There being no other comments, Mayor Boddy declared the Public Meeting closed at 5:56 p.m.

In response to a question from Council, Mr. Wakeford advised that this is the perfect location for a rock-climbing gym because his building has a 25 foot ceiling, whereas no other buildings in the area with appropriate zoning have this feature.

7. DEPUTATIONS AND PRESENTATIONS

7.a Deputation from Sarah Durrer, CMHA Grey Bruce Re: 9th Annual Ride Don't Hide

Sarah Durrer of the Canadian Mental Health Association (CMHA) Grey Bruce provided a deputation on the 9th Annual Ride Don't Hide event scheduled for Sunday, September 17, 2023, and advised that Ride Don't Hide is a national CMHA fundraiser happening in communities across Canada to raise awareness about mental health. Ms. Durrer noted that the CMHA has raised over \$450,000 for local mental health initiatives over the past nine years.

Ms. Durrer noted that the event will be hosted at the Owen Sound Kiwanis Soccer Complex and there will be routes for all riding levels, including 80 km, 40 km, 20 km, and 10 km, as well as a 5 km family friendly route along the trail system to the Bayshore Community Centre.

Ms. Durrer advised that Ride Don't Hide Grey Bruce's mission is to raise mental health awareness, celebrate the participation of our community, and raise critically needed funds for local mental health programs.

Ms. Durrer noted that in the event of a weather watch for the area, the ride will be cancelled.

Ms. Durrer noted that the CMHA is requesting support for cross promotion through social media, support from municipal staff for safety planning, Council attendance on the day of the event to give greetings and provide Owen Sound swag and information to hand out to promote Owen Sound to out of town participants. In response to a question from Council, Ms. Durrer noted that individuals can register for the event through <u>ridedonthide.com</u> and then select the Grey Bruce area.

7.b Presentation from the City Manager Re: Monthly Update

The City Manager provided an overview of the key highlights since his last update.

Mr. Simmonds noted that:

- Tickets went on sale last week for "A Deadly Pairing", a major fundraising event at Coffin Ridge Winery on September 8 to support the Tom Thomson Art Gallery;
- The Sound Waterfront Festival saw record attendance at both the Owen Sound Visitor Centre and Kelso Beach at Nawash Park;
- Summerfolk and the Salmon Spectacular were issued tent permits for their respective events;
- Removal of Ash trees is underway;
- City and County staff met with MPP Rick Byers to discuss affordable/attainable housing;
- Service Review Recommendations and Actions are moving forward; and
- The Harrison Park Cabin has successfully launched for weekly rentals offering a new campground opportunity.

Lastly, Mr. Simmonds noted the reports that will be presented to the Corporate Services Committee, Operations Committee, Community Services Committee, and Community Development, Tourism and Culture Advisory Committee in September.

8. PUBLIC QUESTION PERIOD

8.a Jim Hutton, Owen Sound resident, emailed the following questions to the City Clerk prior to the meeting respecting preparation time for Council meetings and the MNP Service Review Final Report:

Will Council direct staff to provide Councillors with the Council meeting agenda materials and post these materials to the City website one week in advance of Council meetings? Will Council direct staff to provide the final MNP Report to the public by posting it on the City website so taxpayers can see exactly what they received for their \$108,000?

The City Manager advised that the final MNP Report has been posted to the City's website under the Reports, Studies and Plans section. The City Clerk noted that the Procedural By-law provides the minimum notice requirements for agendas, and should Council wish to change the notice provisions, this could be done through amending the by-law.

10.c Verbal Report from the Deputy Mayor Re: Grey County Council

Deputy Mayor Greig advised that on July 13, 2023, County Council discussed an amendment to increase the upset limit on the Rockwood Terrace rebuild to \$96.7 million from \$92 million. It is estimated that project costs for the 128 long-term care bed facility will require borrowing \$77.6 million with an anticipated net levy of \$4,330,000. Beyond this project, the County would have \$2.9 million available annually to finance other projects.

Deputy Mayor Greig noted that resolutions were endorsed by Committee of the Whole to continue work within the County for supportive outreach services funding the program through the Ontario Cannabis Legalization Implementation Fund and the Safe Restart Fund until March 2024. A resolution was endorsed to advance solutions to homelessness prevention which, depending on projects undertaken, could have a net levy cost of \$133,662 beyond the current system of \$1 million approved for motel rooms and damages sustained. Grey County is revisiting the Transportation Master Plan and evaluating urban roads and roads rationalization.

Deputy Mayor Greig advised that 2,021 acres of land was added to the Grey Sauble Conservation Authority Administration Centre property. This property is the Arboretum and consists of the meadow and the Trees of the World. On July 18, an event was held to acknowledge and celebrate the completion of the Fulfilling the Dream Signage Project. The project was made possible through funding from the TD Friends of the Environment Foundation and fulfilled a 60year-old dream to fully label the Arboretum, identifying the 165 different species of wooden plants found native to Grey Bruce and some from around the world. Deputy Mayor Greig congratulated the Grey Sauble Committee and the Arboretum Alliance and thanked the TD Friends of the Environment Foundation for their sponsorship.

15.b Mayor's Update

- He attended the 9th Annual Metis Fish Fry at Hibou Conservation Area. There were approximately 100 to 150 people in attendance. Hibou and down the eastern shoreline are traditional Metis lands.

- He attended the One Can Challenge at Seasons Retirement Home last week. Residents and staff challenged each other to collect cans of food for the Food Bank. They collected over 350 cans of food and Seasons donated \$2,100.
- He attended MP Alex Ruff's picnic on Sunday, July 24 where MP Ruff presented King Charles coronation pins for merit and contribution to the community to several individuals, including Stew Patterson, Bill King, Bev Wilkins, and Krista Linthorne.

AND WHEREAS strong mayor powers also give mayors the ability to hire and fire senior municipal staff, which could create an environment where the independence and professional input of senior staff is influenced by this power dynamic;

AND WHERAS the independence of municipal staff is essential for the effective and transparent working relationship between staff and councils as a whole;

AND WHEREAS the precedent of strong mayor powers in some Ontario municipalities might justify the extension of those powers to all municipal councils;

NOW THEREFORE BE IT RESOLVED THAT City Council:

- Formally express concern with the creation and expansion of these powers and highlight that they are not compatible with a democratic process through a letter to Premier Doug Ford, Minister of Municipal Affairs and Housing, Steve Clark, Bruce-Grey-Owen Sound MPP Rick Byers, the leaders of the Ontario Liberal, NDP, and Green Parties, as well as the other municipalities in Ontario; and
- 2. Request staff to monitor the expansion of these powers and report back should opportunities for consultation on the issue become available."
