I write in support of the rezoning application relating to the proposed rock climbing gym at 1580 20th Street East.

My climbing experience spans from 1996 to present and I have had the privilege of visiting rock climbing gyms in multiple countries. The majority of these gyms are located in converted warehouses in industrial areas.

Climbing gyms act as meeting and training spaces for persons with healthy, active and outdoor lifestyles.

The gyms further act as spaces for childrens' parties and summer camps, and general community hubs.

Owen Sound is in desperate need of spaces where physical activities can be pursued indoors during the long winter months, particularly for children, youth and families. To retain a younger generation in our City, we need to promote activities and opportunities that are appealing to young families.

I also know that the climbing gym operators have struggled to find any other location in the City due to limited building heights at all other potential sites. Hi Briana (I believe this is to whom I should be addressing this email:)),

I have been a resident of the Owen Sound area for 21 years, and have 2 teenagers. We started going to climbing gyms 10 or so years ago - when we became good friends with a family of new Canadians who then moved from Owen Sound to Guelph for greater ESL support. Finding things to do with the kids when visiting Guelph was sometimes challenging as they ranged in age from 5 to 11. Climbing at Guelph Grotto quickly became a go-to activity for both winter and bad weather days in summer. We all had our own (second hand) climbing gear at one point, and would often bring additional kids because it was so much fun. About 2 months ago, my teenage son and I started climbing outdoors in the Owen Sound area, and discovered what seasoned climbers will already know, we live in a climber's paradise here! We have met folks from all over southwestern Ontario, and this is definitely a popular destination for climbing. I believe having a climbing gym would encourage climbing folks to spend time in Owen Sound - maybe for accommodation, stock up on essentials, and of course to practice their climbing skills at the gym on days that are not as well suited for climbing outdoors.

We are the lawyers for R. K. Radbourne Building Ltd which is the owner of 1887 Ninth Ave East, Owen Sound. Our client's property is located directly across from the property at 1580 20th Street East, Owen Sound ("Subject Lands").

Our client wishes to provide comments on the zoning by-law amendment application known as ZBA No. 50 which proposes to rezone the Subject Lands from 'Heavy Industrial' (M2) and 'Hazard Lands' (ZH) to 'General Industrial' (M1) and 'Hazard Lands' (ZH). For the reasons that follow, our client suggests that ZBA No. 50 as proposed should not be passed by City Council.

The Subject Lands currently operate as operate as an industrial mall and have had a variety of uses over time since construction of the existing building was completed in 1976. Many of the uses over time appear to have been in accordance with the M2 zoning in place for the Subject Lands. However, in more recent times the Subject Lands have hosted uses such as a "clinic" which is not a permitted use in the M2 zone. There may be other current uses of the Subject Lands which do not conform to the M2 zone.

The current application seeks to rezone the Subject Lands in order to permit a "Community Lifestyle Facility". We note that a "Community Lifestyle Facility" is permitted in both M1 (Light Industrial) and MU (Mixed Use Industrial) zones. Our client suggests that the more appropriate zoning category for the Subject Lands would be the MU zone which permits



the "Community Lifestyle Facility" desired by the applicant and which would legalize those uses on the Subject Lands which are currently not permitted in the M2 zone or the proposed M1 zone.

Rezoning the Subject Lands to the MU zone would also be appropriate and compatible with surrounding lands, including our client's lands, which are transitioning into a variety of mixed uses with some modest industrial components. Simply rezoning the Subject Lands to the M1 zone is not a reflection of the ongoing and future development of an area of the City that is undergoing rapid redevelopment with a shrinking industrial focus.

We wish to be notified of any decision Council makes with respect to this application.
