## 1. Call to Order

# 2. Land Acknowledgment

I would like to respectfully acknowledge that we are meeting on the traditional lands of the First Nations and has been inhabited by Indigenous peoples from the beginning. In particular, I acknowledge the history, spirituality, and culture of the Territory of the Anishinabek Nation; the People of the Three Fires known as Ojibway, Odawa, and Pottawatomi Nation and further give thanks to the Chippewas of Saugeen, and the Chippewas of Nawash, known collectively as the Saugeen Ojibway Nation, as the traditional keepers of this land. We recognize and deeply appreciate their historic connection to this area as well as the contributions of Métis, Inuit, and other Indigenous peoples whose ancestors shared these lands and waters. # 9. Chairman's Report

From May 30 to June 1, Chair Thomson attended the OAPSB AGM and Spring Conference. During the AGM, directors for 2023 were confirmed by the membership and an election of officers took place. Patrick Weaver was re-elected as Chair, Bill Hagborg as 1st Vice Chair, Jim Maudsley as 2nd Vice Chair and Secretary, and Karen Fisher was re-elected as Treasurer. The Treasurer reported that the OAPSB received a clean audit report and appointed Baker Tilly Trillium LLP as auditors for the 2023 financial statements.

Chair Thomson mentioned that all directors and their BIOs are available on the OAPSB website as well as presentations from the AGM and conference.

The Spring Conference had the highest attendance in the last 5 years. The topics covered a wide spectrum, including police branding, a collaboration between OAPSB

and OACP, a speech by Ryan Teschner on improving performance and public safety confidence, a case study on strengthening governance in Thunder Bay, and workshops on board evaluation, monitoring performance, and communication and public relations.

Chair Thomson also attended a Zone 5 meeting via Zoom on June 6, where guest speakers from the Inspectorate of Policing discussed their roles. An issue brought up during the meeting was school boards in southern Ontario banning police officers from some schools. The next meeting is scheduled for September 12, 2023, in Guelph.

On June 21, Chair Thomson participated in the sunrise ceremony at the Gichi - Wiikewedong Reconciliation Garden at Kelso Beach in recognition of National Indigenous People's Day.

Later, on June 28, Chair Thomson attended the OAPSB's annual strategic planning session in Toronto, where they reviewed the strategic plan, action plans, and budget. The transfer payment agreement for training was flexible due to the delayed CSPA, and new committee members were named for Advocacy, Human Resources, OMERS, and finance committees.

During the session, the structure and administration of zones were revisited, and an ad hoc committee was formed to review this in the coming months. The Labour Conference is the next event on the agenda, scheduled for the fall, with the date and venue yet to be confirmed.

Chair Thomson noted that at the May meeting that the board approved 91 updated policies in the open session. There are still five that require minor updating. The remaining two of the Admin 016 Financial Management Policy and Admin 018 Reimbursement of Expenses have been combined into a new **OSPSB General Policy-010** Financial Management.

Once the remaining seven have been reviewed by the board, they will be officially approved at our September meeting.

Chief Ambrose noted that with the prolonged vacancy of a Financial Coordinator, the invoices had not been sent out but we have continued to pay bills. With the position filled now, the invoicing is being brought up to date. The City was anticipating a deficit of approximately \$285,000. However, upon reviewing their financials, there is revenue of over \$130,000 that has not been invoiced, along with outstanding payments for services provided but not invoiced. Chief Ambrose added that once the financial records were updated, the deficit should be significantly reduced, attributing the remaining excess primarily to court costs.

Good Day,

We are a group of residents along 4<sup>th</sup> Avenue West (and in the immediate vicinity) from about 12<sup>th</sup> St. West to 14<sup>th</sup> St. West (see map attached) who are proudly committed to our Owen Sound neighbourhood. However, we have become extremely concerned about crime, nuisance behaviour, overdoses, disturbances and other drugrelated aberrant behaviour in our neighbourhood over the past year.

We are a close-knit group of homeowners who came together during the first summer of the pandemic to clang pots and pans every Friday night to support frontline health care workers and nursing home residents, and even walked down to the Lutheran Nursing home to clang and sing for the residents. As a neighbourhood, we look out for one another and we keep in regular contact. We all enjoy this neighbourhood and would like to keep it and ourselves safe.

Over the past year, we have all become <u>very</u> alarmed at the increasing lawless behaviour of people wandering the neighbourhood and passing through. There have been people overdosed and unconscious on people's lawns and in the middle of the road, there have been people trespassing, there have been fights on people's front lawns, there has been aggressive and sometimes threatening behaviour from people high out of their tree, there have been "door knocks" from people with very flimsy reasons for wanting to get inside. My house is on the quiet little street of 3<sup>rd</sup> Ave "A" W, which is tucked right in behind 4<sup>th</sup> Ave. Earlier this spring, three neighbourhood men had to very

aggressively run off a man who was trying to break into a garage, was not making any sense, and who was acting very strangely and confrontationally. THIS IS NOT NORMAL BEHAVIOUR for this neighbourhood (and that is just one example)! Many, in fact most, of these incidents have been occurring during daylight hours. It is very troubling to see residents have to clash with these troublemakers to protect their property and to defend themselves. It is worrisome sometimes even to walk your dog in broad daylight.

We are not unsympathetic to the supports badly needed for addicts and homeless people (the food bank and Parkway Apts subsidized housing are in our neighbourhood and soon the new transitional housing are all meant to support those in need, which we appreciate). But there seems to be a disproportionate amount of problems cropping up here lately, and perhaps more resources are needed to combat the problems that sometimes follow some of the folks who are in need of housing, mental health and addiction supports. I urge you to check the police calls from this area over the past few months to confirm the problems in our neighbourhood. Most of us have recently put up more fencing and added security lights and sometimes cameras. We call police when we see a problem. We talk to one another about what we're seeing. What else are we supposed to do to keep our neighbourhood safe?? What happens to a good neighbourhood when residents get fed up and move out??

Our hunch is that there are a lot of problem tenants in the Parkway Apt building on 14<sup>th</sup> St. West. We see them cutting through the back parking lot of the Parkway building (where there is supposed to be a fence!), which spits them out into a right-of-way off 13<sup>th</sup> St. West. Right off this right-of-way, there has been at least one overdose, a bicycle stolen and other issues.

Actionable items we would like addressed immediately:


1) Replace the fence at the back parking lot of the Parkway building (with something impenetrable) that has been in terrible disrepair for decades (see photo attached). Put up lighting back there. It's long past time for Grey County to be a better neighbour! Perhaps there are other things that could be done on that property too... security cameras?

- 2) The police and city/county to crack down on the bad tenants in the area and their behaviour. Who are these people and where are they coming from and going to when they are stumbling through our neighbourhood? Are there other "houses" or buildings besides the Parkway highrise that seem to house problem residents? Is it the same handful of people causing all our problems or is it more? Are these people in breach of conditions?
- **3)** We respectfully request that our letter be included in the next (or soon after next) council packages for the city and county and for the next city police board meeting.

We also might remind you that there is a daycare center on  $4^{\rm th}$  Ave West (at the old St. Thomas Church) and the children play in the front yard of that facility all day long.

Please feel free to contact or meet with me or any of the homeowners on this list. All of us below are in signature of this letter. We would like an update at some point this summer on what is being done. Thank you.

#### **REPORT:**

#### **Investigations**

**Aggravated Assault** – (May 14<sup>th</sup>, 2023) Members of the Criminal Investigations Branch assisted uniform patrol where the victim, a 30-year-old, Sauble Beach man was stabbed multiple times by the accused, a 34-year-old, Owen Sound man. The victim's injuries required surgery and further hospitalization for five days. A residential search warrant was completed on the residence of the accused's parents with the assistance of the Ontario Provincial Police Tactics and Rescue Unit (TRU). The accused was not located during that warrant however was arrested by police the following day. The accused remains in custody and has been charged with aggravated assault, assault with a weapon (2 Counts) and possession of a weapon for a dangerous purpose. The victim is expected to make a full recovery.

**Weapons Offences** – (May 30<sup>th</sup>, 2023) Members of the Criminal Investigations Branch assisted uniform patrol where the accused, a 31-year-old, Owen Sound man threatened multiple residents in a rooming house he was residing in. The investigation revealed that the accused had also brandished a firearm and pointed it at one of the residents. The accused was arrested by police with respect to the offences: Uttering Threats (2 Counts), Pointing a Firearm, Unauthorized Possession of a Firearm, Possession of a Firearm Contrary to a Prohibition Order, Fail to Comply-Release Order and Fail to Comply-Undertaking. The accused remains in custody.

Extortion and Distribution of Intimate Image - (October 18<sup>th</sup>, 2022 – UPDATE) Police received a complaint with respect to the distribution of an intimate image. The investigation revealed that the 17-year-old female victim had shared intimate images of herself with an unknown person over a social media application. The unknown person then told the victim if she did not send further images or money, they would share the images they already had, with her friends and family. When the victim did not give in to the demands of the unknown person, they sent her images to numerous people over social media. Multiple production orders were obtained that identified a residence in Burnaby, British Columbia where the unknown person had communicated with the victim from. In January, 2023, Burnaby RCMP – Child Exploitation Unit obtained a search warrant for the Burnaby residence and located devices that contained multiple images and messages from victim's across Canada. In May, 2023 the victim from Owen Sound, was identified on one of the devices seized by police. The investigative package from the Owen Sound Police Service was forwarded to the RCMP and as a result,

an 18-year-old, Burnaby man will be charged with extortion, possession/distribution of child pornography and publication of intimate images.

SUBJECT: Auxiliary Board Report – May 2023

#### **REPORT:**

The month of May was busy for the Auxiliary Unit with outdoor events gearing up in the warmer weather! A total of 139 volunteer hours were given by the Auxiliary Unit this month.

On May 6<sup>th</sup> the Auxiliary attended the "Race for REACH" fundraiser event at Harrison Park where hundreds of participants ran/hiked/walked/biked a 5 km event. Members engaged with the participants and provided some direction and assistance with traffic control for safety purposes.

On May 8<sup>th</sup> members of the Owen Sound Police Service as well as the Auxiliary Unit attended Zehrs Grocery Store for the "Shop with a Cop" event. This event was in partnership with the Optimist Club as a fundraiser for the local Salvation Army. Children from a local elementary school got paired up with an Officer who helps them shop for food items to donate.

On May 17<sup>th</sup>, 2023, Auxiliary members attended a local high school with CSO Jason Cranny for a traffic Safety Blitz to educate young drivers on the dangers of drinking and driving before the May long weekend.

On May 27<sup>th</sup>, members further participated in the Hike for Hospice, as a team from OSPS entered the fundraiser hike together in support of the Chapman House in Owen Sound.

On May 29<sup>th</sup>, the Auxiliary Unit had a scheduled monthly meeting, which this month's topic was Firearm Familiarization. Training Officer Carlo Obillos presented on different types of firearms, safety practices and brought samples of our Service issued firearms. Cst. Obillos specifically showed the Auxiliary members how to retrieve a carbine from the vehicle mounts, should they ever need to access it for the escorting officer while on patrol. They were also shown how to remove a firearm from an officer's holster and proper safety techniques should they ever be put in a situation that required them to handle a firearm in an emergency.

In May the new class of Auxiliary Recruits had commenced their training with Sergeant Liz Cranny, Auxiliary Liaison Officer, and assisted by Cst. Obillos. The training program is 6 weeks in length, with 2 sessions per week in the evenings. The new Auxiliary Recruit class consists of 7 new members for the Unit with training scheduled to be complete before the end of June.

Prisoners are not transported to the courthouse unless they are attending for their trial, Counsel/Judiciary/Crown Attorney has requested an in-person attendance or the correctional facility is unable to accommodate them appearing virtually due to video booth scheduling. All other prisoners are still being done by audio/video from the police services or the correctional facilities.

Special Constables have been assigned at the police station to cover in-custody hearings. When not required for prisoners in custody members have assisted to perform other duties.

#### **REPORT:**

Human Resources - May 2023: As shown in the attached May 2023 monthly report, as of the end of May, the OSECC was carrying 1 full-time and 4 part time Communicator vacancies. In May, 6 new part-time Communicators were onboarded, although training was discontinued for 1. A seventh job offer in May was declined. There were 92 hours of sick leave, and 234 hours of mandatory overtime in the OSECC during May.

The OSECC participated in the Fanshawe College Telecommunicators Co-Op Program in May and hosted 2 Co-Op students. The Co-Op students were assigned a mentor for 160 hours and had an opportunity to observe and process all tasks within the Communications Centre.

911 Calls - May 2023: There were 7,261 emergency calls from the 911 phone line into the OSECC in May, representing an average rate of 234/day (compared to 204 last month). This is a 25% increase from May 2022, and a 13% year-to date increase from last year. The volume of "No Answer" 911 calls is rising most significantly: 655 in May 2022 compared to 1,074 in May 2023. Year-to-date, the "No Answer" 911 calls have increased by 40%. Correspondingly, the volume and rate of transferred calls and calls dispatched by OSECC are also increasing. There were 1,921 emergency calls from the 911 phone line dispatched in May, representing an average daily call rate of 62 (compared to 51 last month), and a year-to-date increase of 10%.

Computer Aided Dispatch (CAD) Events – May 2023: As shown in the May 2023 report, there were 5,831 calls dispatched in the OSECC this past month, representing an average dispatch rate of 188 per day (compared to 179 last month). This is an 11% increase from May 2022, and a 12% increase year-to-date. The six police services within the OSECC accounted for 92% of dispatched CAD events in May 2023. OSPS' 1,736 CAD events dispatched in May 2023 represent 30% of the month's volume, and have increased by 11% year-to-date compared to 2022.

Information Technology (IT) Infrastructure – May 2023: The implementation and training required for migration to NG911 later this year is a considerable focus. During the month of May and June, substantial work at the alternate Communications Centre site was undertaken. Incoming transfers and initial calls for NG911 were completed with outbound transfers being finalized.

Work is also being done on a contract for the 7 Public Safety Answer Points (PSAPs) to cover off liability. The document was drafted by IT Director Chris Hill and is currently being reviewed by an Owen Sound Law Firm. This contract will also include a support matrix of responsibilities for each agency involved.

Project design and implementation has begun with OSECC's NG911 partners, with progress on NG911 network installation for these sites confirmed (Bell Canada looks after the NG911 connectivity in Ontario). These installations vary based on location and the services available (construction requirements, geographic limitations, etc.). Additionally, call process design has started for each agency on their customized system requirements.

## FINANCIAL/RISK IMPLICATION(S):

Risk management and contingency planning are integral to the day-to-day operations of a Public Safety Answering Point. While the OSECC continues to grow and evolve, OSPS strives to maintain a balance of staffing that best aligns with workload demands, member wellness, emergency response standards, and contracted client expectations.

#### **OPERATIONS PLAN:**

Within the 2023-2026 OSPS Operations Plan, six unique actions have been identified as important to reach towards the goal of fostering a sustainable emergency communication centre. In addition, monitoring and publishing emergency response times to priority calls is part of the goal to address safety concerns identified by the community.







#### **Grey County Radio System**

During the month of May and parts of June, OSPS IT worked on improvements of the shared Grey County Radio System that it maintains on behalf of the County. Upgrades included network improvements and an additional site in Midland for increased coverage in the Town of Blue Mountains area. This work is completed under a revenue generating contract with the County to administer/maintain their system in co-ordination with original vendor.

#### **Phone System Upgrades**

IT have completed testing of the new phone system for administrative purposes with configurations to allow us to proceed with placing new phones on the desks with no downtime/loss of functionality to clients. New phones will now begun to be installed on desks and preprogrammed for use on migration day to be determined. The new phone system is tied to our NG911 platform and will also allow our staff to have enhanced features on mobile phones and conferencing.

#### Saugeen Shores Video Recorder

OSPS was successful in winning a Request for Proposal against several competitors/vendors in providing a reliable and efficient video recording solution for their Police Service. At time of writing, all components have arrived and work is slated to begin very shortly. This work is an additional revenue source for OSPS IT Branch.

As discussed previously the design is free with our commitment to 3 years.


The Association is more than satisfied with the design and the organizer is awaiting final approval. If the Board approves the design than the association will give the organizer the go ahead.
