#### **Recommendations:**

THAT in consideration of Staff Report CR-23-085 respecting Appointment of Council Members to the Strategic Planning Ad Hoc Committee, City Council directs staff to bring forward a by-law to amend the Board and Committee By-law to appoint Council members to the Strategic Planning Ad Hoc Committee as selected through the established Nomination Procedure.

### **Background:**

City Council approved the establishment of the Strategic Planning Ad Hoc Committee on September 11, 2023. As per the approved Terms of Reference (Attachment 1), the committee will be comprised of:

- Three (3) members of Council; and
- A minimum of three (3) and a maximum of seven (7) public members.

The purpose of this report is to appoint three (3) Council members to the Strategic Planning Ad Hoc Committee.

The public members will be appointed by Council at the meeting on November 6, 2023.
