10. REPORTS OF CITY STAFF

10.a Verbal Report from the Deputy Mayor Re: Grey County Council

Deputy Mayor Greig relinquished the position of Chair so that he could provide his Verbal Report. Councillor Kukreja assumed the position of Chair.

Deputy Mayor Greig advised that on October 26, 2023, County Council amended the Terms of Reference for the Grey County Joint Accessibility Advisory Committee to increase the membership from seven (7) to nine (9) members in response to the request from the City of Owen Sound. The recruitment process for the two positions will begin soon and any appointments will be returned to County Council for endorsement.

County Council reviewed the draft 2024 budget that has a proposed levy increase of \$9,979,300 over 2023. The process began on October 24, 2023 with an increase of 14.7% in levy cost before growth being accounted for. County assessment growth in 2023 will be approximately \$1.65 million, lowering the levy increase to approximately 12%. County Council discussed various items, totaling approximately \$5 million, that could be removed from the draft 2024 budget to further reduce the levy increase.

In response to a question from Council, Deputy Mayor Greig noted that there was a large addition to the proposed levy due to the reconstruction of Rockwood Terrace in Durham as well as implementing enhanced response times for paramedics through Grey County.

Councillor Merton advised that The Institute of Southern Georgian Bay is hosting a forum on November 17th at the Meaford Hall on 'New Ways to Finance the Housing Affordability Gap'. The forum will be open to the public in the morning from 9:00 a.m. to 12:30 p.m. and you must pre-register on their website at www.tisgb.com. The forum is by invitation only in the afternoon from 12:30 p.m. to 3:00 p.m. for a focused workshop. Councillor Merton noted that research being conducted in our region is identifying the need for purpose-built rentals for workers in health, hospitality, retail, recreation, arts, and entertainment who are key to providing services in our communities.

15.b Gichi-Name Wiikwedong Reconciliation Garden Committee's Thank You Event

Councillor Middlebro' noted that she attended the Gichi-Name Wiikwedong Reconciliation Garden Committee's Thank You event on October 25th at Cobble Beach to bring remarks on behalf of Council and the Mayor. This event recognized those who have been involved with the Gichi-Name Wiikwedong Reconciliation Garden from 2010 until today. The City was gifted with a handmade bowl that will be put on display somewhere in the City.
