1. CALL TO ORDER

Mayor Boddy called the meeting to order at 5:30 p.m.

2. CALL FOR ADDITIONAL BUSINESS

6. PUBLIC MEETINGS

6.a Zoning By-law Amendment No. 51 - Housekeeping (Short-Term Rentals)

Mayor Boddy declared the Public Meeting open at 5:32 p.m. and read the following announcement:

- Every person who attends a statutory public meeting required under the Planning Act shall be given an opportunity to make representations in respect of the proposed by-law.
- All submission materials for this application are available on the City's website and at the Planning Division, City Hall during regular business hours.
- If a person or public body would otherwise have an ability to appeal the decision of the Council of The Corporation of the City of Owen Sound to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to The Corporation of the City of Owen Sound before the Zoning By-law Amendment is passed, the person or public body is not entitled to appeal the decision.
- If a person or public body does not make oral submissions at a public meeting or make written submissions to The Corporation of the City of Owen Sound before the Zoning By-law Amendment is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

The City Clerk explained that notice of the Public Meeting was published in The Sun Times, circulated to the prescribed persons and bodies, and placed on the City's website on November 9, 2023. No comments have been received. The City Clerk encouraged those present for the public meeting to sign the sign-in sheet located on the table outside of Council Chambers.

The City Clerk advised that personal information is collected under the authority of the *Planning Act*, and that the information collected will be used to complete the Zoning By-law Amendment process and will form part of the public record. Questions about this collection should be addressed to the City Clerk.

The City Clerk advised that any person wishing to receive notice of the decision of The Corporation of the City of Owen Sound on the proposed Zoning By-law Amendment application must make a written request to the City of Owen Sound.

The Manager of Planning and Heritage provided a presentation on Zoning By-law Amendment (ZBA) No. 51 put forward by the City of Owen Sound to implement housekeeping changes to support the implementation of a Short-Term Rental Licensing By-law by clarifying where in the City Short-Term Rentals (STRs) are permitted and providing associated definitions. The ZBA is City-wide and impacts several zones. Ms. Robart advised that STRs will be permitted in any zone where a 'Residential Use' is a permitted use and will be permitted in any dwelling type including single family, semi-detached, duplex, townhouses, and apartments. STRs will also be required to comply with the parking provisions of Section 5 of Zoning By-law 2010-078, as amended.

Ms. Robart explained that the definition of a 'Bed & Breakfast' in the Zoning Bylaw will be refined to clarify that a 'Bed & Breakfast' is operated as a home business by the resident operator, the accommodations do not include cooking facilities, and meals, services and facilities are offered exclusively to the guests and are not available to the general public. Ms. Robart advised that Home Occupation will be deleted as a specific permitted use in Section 6 Residential zones and Section 5.17 will be amended so that home businesses are permitted anywhere a Residential Use is permitted in the Zoning By-law, including in the commercial zones where residential uses are permitted.

Ms. Robart highlighted the ZBA process to date and advised that a recommendation report and enacting by-law are tentatively scheduled to be presented to Council on December 18, 2023.

Mayor Boddy invited members of the public to ask questions or provide comments on the ZBA.

Linda Perks, Owen Sound resident, noted that the Zoning By-law includes a definition for dwelling and dwelling unit. The definition of a dwelling unit makes it sound like it is not intended for transient occupancy which seems to be the definition of a short-term rental, and thus, would not be compatible in residential zones. Ms. Perks advised that the average occupancy for Owen Sound as per the 2021 census is 2.1 people per household, and thus, short-term rentals would not be compatible in residential zones where a maximum of eight (8) people are being permitted to stay in one dwelling unit. Ms. Perks cited concerns with nuisance and the police response time for responding to these types of calls in the evenings. Ms. Perks noted that the federal government has announced \$50 million in funding to support municipal enforcement of short-term rentals and wondered if perhaps the City could use this funding to assist with having a Bylaw Enforcement Officer available after hours to respond to complaints as most of the nuisance issues with short-term rentals occur after hours. Ms. Perks inquired as to the parking requirements for short-term rentals and if additional requirements are required for properties that are located in hazard zones.

The Director of Community Services advised that responses to these comments and questions will be brought back to Council on December 18th through the recommendation report.

There being no other comments, Mayor Boddy declared the Public Meeting closed at 5:48 p.m.

7. DEPUTATIONS AND PRESENTATIONS

7.a Deputation from Joachim Ostertag, Violence Prevention Grey Bruce Re: National Day of Remembrance and Action on Violence Against Women

Joachim Ostertag from Violence Prevention Grey Bruce provided a deputation to Council respecting the National Day of Remembrance and Action on Violence Against Women on December 6, noting that this year marks the 34th anniversary of the murders of 14 young women at École Polytechnique de Montréal. This is a day of remembrance and a time to take concrete action on Violence Against Women in our families, communities, places of work, schools, and places of worship. Mr. Ostertag provided statistics on the number of femicide victims in Canada and Ontario, the number of women who were supported by the Women's Centre Grey Bruce so far this year and noted that violence against 2SLGBTQ+ members is on the rise in Canada and locally in Grey Bruce.

Mr. Ostertag noted that on December 6, an outdoor vigil will be held at the Owen Sound Farmers' Market to recognize the National Day of Remembrance and Action on Violence Against Women and to remember the victims of the 1989 Montreal Massacre.

Mr. Ostertag advised that Violence Prevention Grey Bruce is requesting that the flags be lowered to half mast on December 6 and that City Council be represented at the commemoration event at the Farmers' Market.

8. PUBLIC QUESTION PERIOD

8.a Grant McKinnon, Owen Sound resident, emailed the City Clerk prior to the meeting with the following questions respecting the Tom Thomson Art Gallery:

To date in 2023, how many people did the Art Gallery record visiting the Gallery? What is the City provided subsidy on a per person visit basis?

The Director of Community Services advised that the Art Gallery tracks in person attendance as well as attendance under the category of Arts, Education and Learning, and Community Project Outreach, along with digital engagement. As of August 2023, the in-person attendance is trending higher than the pre-pandemic years of 2018 and 2019. The estimate to year end based on the planned exhibits for the remainder of the year is 25,000 in-person visitors. There are an additional 3,000 visitors under the category of Arts, Education and Learning, and 10,000 visitors under the category of Community Project Outreach, with a digital engagement reach of 300,000 people. The City subsidy on a per person basis is \$9.

In response to a question from Council, the Director of Community Services noted that there are currently 10,597 people with an OPEN Card.
