**Subject**: 2024 Council Board and Committee Selections

#### **Recommendations:**

THAT in consideration of Staff Report CR-23-120 respecting 2024 Council Board and Committee Selections, City Council directs staff to bring forward the 2024 Board and Committee By-law to appoint Council members to serve on Boards and Committees with terms effective February 1, 2024.

## **Highlights:**

- Councillors will make committee selections at this meeting with terms beginning February 1.
- Councillors who are on Boards for multiple years may pass on a round of selections during the selection process.
- Selection changes required due to scheduling conflicts can be made by notifying the Deputy Clerk by January 3.
- The by-law to formalize the committee appointments will be presented at the January 15 Council meeting.

### **Background:**

In accordance with Policy No. CrS-C37 (Attachment 1), City Council will make selections for seating arrangements and Board and Committee representation which will be effective February 1, 2024, and expire on January 31, 2025. To divide appointments more evenly, Councillors who are on Boards or Committees for multiple years can pass on a round of selections during the selection process.

The 2024 Board and Committee Selection Sheet (Attachment 2) outlines the vacancies available.

The 2024 Council and Committee Meeting Calendar (Attachment 3) has also been attached for ease of reference. The Community Organizations that Council members may be appointed to are not included in the calendar. Their meeting dates and times are noted below:

Due to these ongoing appointments, the following Councillors have the following number of passes during the selection process should they wish to use them:

If there are scheduling conflicts and Council members need to make changes to their Board and Committee selections, the Deputy Clerk needs to be advised of any changes by 4:30 p.m. on January 3, 2023.

At the first meeting of each committee following the new appointments, there will be an election of the Chairs and Vice-Chairs. As per the Board and Committee By-law, Chairs and Vice-Chairs of Standing Committees are members of Council. A Council member can serve as Chair for no more than two (2) years consecutively, and at the end of the second year, the Council member shall not be eligible to serve as Chair for that committee for one (1) year. A Council member is also prohibited from serving as the Chair or Vice-Chair of a City committee where they are a family member of the committee's staff liaison.
