8. PUBLIC QUESTION PERIOD

8.a Andrea Ingham, Owen Sound resident, asked the following questions respecting River District businesses and homelessness statistics:

Has the City conducted a survey on how the impending deadline for the repayment of the COVID small business loan might affect businesses in the River District Business Improvement Area? Does the City have a strategy for small business closures and assisting the River District if businesses are affected?

How many homeless people are in Owen Sound in relation to comparable rural municipalities?

Deputy Mayor Greig advised that the Canada Emergency Business Account (CEBA) loan is a federal program.

The Director of Community Services noted that Josh Gibson from Grey County has shared a presentation on homelessness statistics, and she can share this presentation and Mr. Gibson's contact information with Ms. Ingham.

Deputy Mayor Greig advised that the Canadian Federation of Independent Business (CFIB) and both the national and provincial Chamber of Commerce have been conducting advocacy efforts on the CEBA loan to keep businesses involved and informed. The Director of Community Services added that the Grey County Business Enterprise Centre has a lot of resources for small businesses.

9.a Memo from the Deputy Clerk Re: River District 2024 Budget

The Deputy Clerk provided an overview of the River District budget process.

In response to a question from Council, the Director of Corporate Services advised that at the time complimentary parking was put into force and the River District began contributing to this cost, there were debenture payments on existing capital projects. In 2023, the City finalized payments on one of the debentures, and 100% of these savings were passed on to the River District.

In response to a question from Council, the Director of Community Services noted that the \$5,000 allocated for celebration relates to the annual Membership Party that all River District members are invited to attend. This event is an opportunity for the members to get together and network with their fellow businesses. In 2023, this event was delivered significantly under budget.

15. DISCUSSION OF ADDITIONAL BUSINESS

15.a Community Need

Councillor Farmer advised that the Grey Bruce Health Unit (GBHU) issued an overdose alert last week following multiple non-fatal overdoses over a span of a couple of days. The alert is in effect until January 18 and is related to toxic lime green fentanyl. The GBHU is reminding people to not use alone, but if you do plan to use alone, to call the National Overdose Response Service.

Councillor Farmer noted that the use of the services provided by OSHaRE and the Salvation Army increased in 2023. The Salvation Army had 1,700 people sign up to receive Christmas food assistance, compared to 1,100 in 2022. OSHaRE served 146,625 meals, compared to 123,600 in 2022.
