7. DEPUTATIONS AND PRESENTATIONS

7.a Deputation from Rashell Feldman, The Southern Georgian Bay Jewish Community Re: Official Definition of Antisemitism

Rashell Feldman of The Southern Georgian Bay Jewish Community provided a deputation respecting the official definition of antisemitism. Ms. Feldman noted that she founded The Southern Georgian Bay Jewish Community in 2023 to provide education and awareness and create a sense of safety in her community, and they currently have over 300 members. After converting to Orthodox Judaism and becoming a mother to five Jewish children, Ms. Feldman noted that she and her family have experienced antisemitism in their local community. Ms. Feldman suggested that the first step in creating safety for Jews in any community is adopting and implementing the International Holocaust Remembrance Alliance's (IHRA's) definition of antisemitism at all levels of government.

Ms. Feldman advised that the IHRA definition has been adopted by the City of Toronto, City of Barrie, Town of Wasaga Beach, Town of Collingwood, and 865 government and institutional entities including the Government of Canada. The IHRA has defined antisemitism as "a certain perception of Jews, which may be expressed as hatred towards Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities." Ms. Feldman noted that The Southern Georgian Bay Jewish Community is asking for Council's support in agreeing to accept and adopt the IHRA's definition of antisemitism and acknowledged that there has been a Jewish presence in Owen Sound for over a century.

Mayor Boddy thanked Ms. Feldman for her deputation and advised that Council will consider her request as policies are developed.

7.b Deputation from Tim Nicholls-Harrison, Owen Sound & North Grey Union Public Library (OSNGUPL) CEO and Shauna Doyle, OSNGUPL Information Specialist, and David Adair, OSNGUPL Board Member Re: Introduction of Poet Laureate, Rebecca Diem

The Owen Sound & North Grey Union Public Library (OSNGUPL) Information Specialist, joined by the OSNGUPL CEO and Board Member, introduced the 2024-2025 poet laureate, Rebecca Diem. Ms. Doyle advised that the Poet Laureate program is hosted by the Owen Sound & North Grey Union Public Library with funding from several members of the community as opposed to taxbased funding.

Ms. Doyle advised that Rebecca Diem writes hopeful speculative fiction and poetry and that her published works can be found on Reactor and Write Magazine. Ms. Diem is the author of the indie steampunk series *Tales of the Captain Duke* and is currently working on a postpartum poetry collection inspired by the natural world and beach walks with a sleeping baby.

Ms. Diem read a poem from her postpartum poetry collection followed by the debut of a new poem "Chi-Miigwech Chi-Cheemaun".

8. PUBLIC QUESTION PERIOD

8.a Yehuda Nestel, Owen Sound taxpayer, asked the following questions respecting antisemitism:

Can you debate whether Israel is a racist country without being antisemitic? Considering that the Jewish community is not united on this question and that this matter falls outside of the scope of your legal responsibilities as a municipal Council, do you think it is appropriate for you to consider adopting the official definition of antisemitism?

Mayor Boddy advised that there is no motion before Council to make a decision and encouraged the Jewish community to put together an appropriate resolution that could be presented to Council for consideration in the future.

- 8.b David Walton, Owen Sound resident and member of Ceasefire Grey Bruce, cited concerns with antisemitism.
- 8.c Rob Rolfe, Owen Sound resident, asked the following question respecting antisemitism:

Will Council be soliciting the views of Owen Sound's diverse local community on antisemitism and islamophobia which is also present in our community?

Mayor Boddy advised that if Council proceeds in the future to consider this topic, then they will consult with the public.

The OSNGUPL CEO and Information Specialist left the meeting.

15.a Control of Animals, Local Butt Blitz, and Day of Remembrance

Councillor Farmer reminded residents that the City has animal control by-laws that restrict pet owners from letting their pets be off leash. Individuals can report concerns of this nature through the Report a Concern webpage on the City's website.

Councillor Farmer noted that the Owen Sound Waste Watchers are organizing a Butt Blitz this month with weekly clean ups of cigarette butts. In 2023, they collected over 22,000 cigarette butts. If anyone is interested in joining them, they can visit the Owen Sound Waste Watchers' Facebook page or contact Anne Finlay-Stewart.

In response to a question from Council, the Director of Community Services advised that the City's garbage picking kits can be booked by contacting Viveca Gravel, River District Coordinator.

Councillor Farmer noted that the We Remember Them event was held on April 6 at the Owen Sound Farmers' Market to commemorate the lives lost over the past year due to drug poisoning. There have been 40 local reports of suspected opioid related drug overdoses in the first three months of 2024, with 35 in Grey County and five (5) in Bruce County. Of those, four (4) people died in Grey County and one (1) person in Bruce County. Councillor Farmer advised that Grey Bruce Public Health will soon have drug testing kits available that will provide individuals with test strips to identify three drugs that could be within the drugs that they are using.

18.a Councillor Farmer Re: Livable Income

Councillor Farmer presented the following Notice of Motion that was supported by Councillor Merton:

"WHEREAS the rising cost of living and rapid inflation are putting significant financial pressure on individuals and families, especially those living in poverty;

AND WHEREAS residents on programs such as Ontario Works receive maximum fixed monthly incomes of \$733, and ODSP recipients receive \$1,376;

AND WHEREAS people living with low income are more likely to be renters and the Community Foundation Focus on Housing report found that in 2021 more than 40% of homes in Owen Sound are rented;

AND WHEREAS rent is considered affordable when it is no more than 30% of gross annual income and the 2021 <u>census reports that 38.3%</u> of tenant households in Owen Sound are spending more than 30% of their income on housing;

AND WHEREAS as of March 31, 2024, there 1,650 Grey County households on the Community Housing Waitlist including only those who presently reside in the area;

AND WHEREAS the <u>2023 Grey County Housing Action Plan</u> identified the need to advocate to the Provincial and Federal governments for housing solutions which may relate to "the 'income' side of the housing affordability equation, for example relating to minimum and living wages [and] social benefits (e.g., ODSP; OW)";

AND WHEREAS poverty also increases food insecurity which negatively impacts physical and mental health especially for <u>children</u> and adequate income is an important social determinant of health that greatly impacts food security;

AND WHEREAS in 2023, the Salvation Army food bank use rose by 42% in Owen Sound and annual meals provided by OSHARE increased 18.6% or 23,000 meals from 2022;

AND WHEREAS in the <u>2024 Monitoring Food Affordability in Grey Bruce</u> report on food insecurity, Grey Bruce Public Health calls on municipalities to "advocate for federal and provincial government policies (e.g.., increases to income tax credits for low-income households) and programs (e.g., basic income guarantee) to ensure an adequate and secure income for all in Canada";

AND WHEREAS in February 2024 the Grey Bruce Poverty Task Force issued <u>a</u> call for income solutions to food insecurity;

AND WHEREAS neither municipal governments nor the non-profit sector have the resources to address the root causes of poverty on their own;

AND WHEREAS decreasing poverty levels benefits individuals and their communities by reducing reliance on food banks, social services, health care, emergency services, and other supports as well as improving quality of life and creating positive local economic impacts;

NOW THEREFORE BE IT RESOLVED THAT City Council join other municipalities across Ontario to urge the Federal and Provincial governments to increase social assistance rates for Ontario Works and the Ontario Disability Support Program and to establish a Guaranteed Livable Income program;

AND THAT this resolution be sent to the Prime Minister, the Premier, the leaders of all parties sitting at Queen's Park, the Minister of Children, Community and Social Services, the Minister of Health, the Minister of Municipal Affairs and

Housing, Alex Ruff, MP for Bruce-Grey-Owen Sound, and Rick Byers, MPP for Bruce-Grey-Owen Sound requesting a response;

AND FURTHER THAT this resolution also be shared with Grey County, Bruce County, the Federation of Canadian Municipalities (FCM), the Association of Municipalities of Ontario (AMO), and the Western Ontario Wardens' Caucus (WOWC)."
