6. PUBLIC MEETINGS

6.a Zoning By-law Amendment (ZBA) No. 53 - 10th Avenue Estates (Graham)

Mayor Boddy declared the Public Meeting open at 5:33 p.m. and read the following announcement:

- Every person who attends a statutory public meeting required under the Planning Act will be given an opportunity to make representations respecting the proposed by-law.
- All submission materials for this application are available on the City's website and at the Planning Division counter at City Hall during regular business hours.
- Recent amendments to the *Planning Act* by the Province now limit appeal
 rights on a Zoning By-law amendment application to the applicant, public
 bodies, and specified persons who made oral or written submissions to
 Owen Sound City Council prior to a decision being made. Specified
 persons generally include energy, railway and telecommunication
 providers as well as NAV Canada.
- This meeting is an essential part of the decision-making process.
 Feedback received will be considered in the decision of the Owen Sound City Council. An explanation of how the public and agency comments factored into the decision will be included in the Notice of Passing of the By-law.
- Where a change is made in a proposed by-law after the holding of the public meeting, Council will determine whether any further notice is to be

given respecting the proposed by-law and the determination of Council as to the giving of further notice is final and not subject to review in any court no matter the extent of the change made in the proposed by-law.

The City Clerk explained that notice of the Public Meeting was posted on the subject property and circulated to the prescribed persons and bodies on June 17, 2024. All comments received prior to the agenda being published were attached to the agenda. One comment was received after the publication of the agenda and will be added to the agenda when it is republished. The City Clerk encouraged those present for the public meeting to sign the sign-in sheet located on the table outside of Council Chambers.

The City Clerk advised that personal information collected at this Public Meeting is collected under the authority of the *Planning Act*, and that the information collected will be used to complete the Zoning By-law Amendment process and will form part of the public record. Questions about this collection should be addressed to the City Clerk.

The City Clerk advised that any person wishing to receive notice of the decision of The Corporation of the City of Owen Sound on the proposed Zoning By-law Amendment application must make a written request to the City of Owen Sound.

The Manager of Planning and Heritage provided a presentation on Zoning By-law Amendment (ZBA) No. 53 put forward by Ron Davidson on behalf of Richard Graham for 10th Avenue Estates. Ms. Robart highlighted the location of the subject lands, noting that the lands are designated Residential and Hazard Lands in the City's Official Plan. The lands are zoned as Medium Density Residential (R4) with Special Provision 14.76, and Hazard Lands (ZH) in the City's Zoning By-law.

Ms. Robart advised that the purpose of the application is to permit an 85-unit residential development consisting of 22 cluster townhouses and two apartment buildings. The effect of the application is to rezone the lands to permit apartment buildings, remove the existing site-specific zoning provisions (14.76) and replace it with site-specific site zoning provisions and building regulations required to facilitate the development.

Ms. Robart advised that a complete application has been submitted and all application materials are available on the City's website. Ms. Robart highlighted the ZBA process to date and advised that a recommendation report and enacting by-law are tentatively scheduled to be presented to Council on July 22 or September 9, 2024.

Ron Davidson, applicant, advised that the development is intended to be a life lease community for seniors aged 55 and older. Mr. Davidson advised that one apartment building is proposed to include four storeys of dwelling units with one level of underground parking, and the other apartment is proposed to have three storeys of dwelling units with one level of street-level parking. Mr. Davidson noted that an emergency access road is proposed to be constructed at the south end of the property, and that this access will be used during construction to avoid traffic through the existing subdivision. Mr. Davidson advised that the ZBA is being requested to allow for a slight increase in building height required for one of the two apartment buildings.

Richard Graham, owner of 10th Avenue Estates Inc. advised that the development is intended to be similar to the existing 9th Avenue Estates, a life lease development that is fully accessible. Mr. Graham noted that the apartment buildings are proposed to meet the density requirements of the Official Plan.

Mayor Boddy invited members of the public to ask questions or provide comments on the proposed ZBA.

Doug Bannister, Owen Sound resident, expressed concerns respecting traffic volumes on 10th Avenue East and 23rd Street 'A' East, as well as concerns about snow clearing.

Peggy Miller, Owen Sound resident, expressed concerns about traffic and parking on 9th Avenue East, as well as about the impact of increased traffic volume on the safety of school children and buses.

Peter Paquette, Owen Sound resident, suggested that another access road be added and that the apartment buildings be located farther from the existing single-family homes.

Scott Miller, Owen Sound resident, suggested that the proposed emergency access road be constructed instead as a permanent two-lane road to alleviate concerns with potential traffic.

There being no other comments, Mayor Boddy declared the Public Meeting closed at 6:20 p.m.

In response to a question from Council, Ms. Coulter advised that any transfer of infrastructure to the City will be addressed in the recommendation report but that typically trunk services are assumed by the municipality and anything else remains with the private owner.

In response to a question from Council, Ms. Coulter noted that details about the road network will be included in the recommendation report and advised of the process through which the design of the road system takes place with reference to the Official Plan and Secondary Plan.
