AMO Policy Update – Energy Procurements, AMO Community and Supportive Housing Event

Ontario Launches Next Round of Energy Procurements

On August 28, 2024, the province announced the next round of long-term energy procurements (called "LT2") under which Ontario will see 5,000 megawatts of additional energy added to the electrical grid – crucial to power houses and businesses as our province grows. AMO President Robin Jones attended the announcement, thanking the province for investing in clean, reliable, and affordable energy.

The ministry <u>has asked</u> the Independent Electricity System Operator (IESO) to report back on the design of the LT2 procurement by September 20, 2024, and to include the following considerations:

- Only moving forward with projects where municipalities have indicated they are willing hosts through a municipal support resolution
- Adopting a technology-agnostic approach that includes all types of generation and storage, including natural gas
- Incentivizing projects in Northern Ontario and those that avoid prime agricultural lands
- Creating a plan to "unlock Crown lands" for renewable energy
- Finalizing the completion of LT2 procurements by February 28, 2026

This approach <u>responds</u> to AMO <u>advocacy</u> regarding the need to protect agricultural lands by: 1) banning ground-mounted solar projects in specialty crop areas and 2) requiring

companies proposing projects on prime farmland to prepare and secure municipal approval on an agricultural impact assessment (AIA).

AMO has been working with municipalities, IESO and the province to ensure that the lessons learned from previous long-term energy procurements are incorporated into LT2 and future procurement processes. AMO is working with IESO and the Ministry of Energy to put new supports in place for municipal governments to help them make informed energy decisions that benefit their communities. AMO is urging the IESO and the Ministry to put new supports are in place by winter 2025 to maximize their usefulness to municipalities.

As energy partners pursue new projects, clear provincial guidelines and municipal-specific resources are essential to enable municipalities to play their leadership role in shaping the future of energy in Ontario.

A MESSAGE FROM THE POLICE SERVICES BOARD CHAIR



On behalf of the Owen Sound Police Service Board (the Board) I am pleased to join Chief Ambrose in introducing the Owen Sound Police Service's 2023 Annual Report.

Police service boards are governance bodies that are responsible for oversight and maintaining a police service to ensure adequate and effective policing by meeting the needs of the population of the area that it serves. As part of board governance and in preparation for the new Community Safety and Policing Act that was enacted April 1, 2024, the Board reviewed, updated and approved ninety-six board policies and twenty-five bylaws during 2023.

In 2023 the Board, in conjunction with OSPS command staff, held extensive consultation with the community and our members to develop a strategic plan for 2023-2026 which contains four Strategic Priorities - Community Safety, Community Wellbeing, Our Members, and Sustainability. This year's Annual Report provides an opportunity to share with the community the successes of year one's progress of our Operations Plan.

The Owen Sound Emergency Communications Centre (OSECC) is one of only two in the province that provides unique dispatching services to a number of other police services as well as fire and county operations.

Year over year your police service continues to see a significant rise in drug, alcohol, mental health issues, and property crime within the city limits. The rise in violent crime was exacerbated in 2023 by three homicides taking place within the span of six weeks, which created an enormous impact on our investigative resources and will continue to draw on resources through the court process. Continued increases in local crime serve to place additional impact on our limited resources.

I would like to thank the members of the Owen Sound Police Services Board for their continued service to the community. In addition to attending board meetings, members of the Board participate in service events and engage in professional development. I am thankful to have a committed team who have a shared vision for police governance.

Our Chief reminds us that policing is a 24/7 operation. While we engage in our daily routines, we can be assured that the members of the Owen Sound Police Service are working around the clock to keep our community safe and well. For this I would like to extend our sincere gratitude to Chief Ambrose, his command staff, sworn and civilian members, special constables and our auxiliary members who continue to display a substantial level of dedication and loyalty to safeguard the citizens of Owen Sound. It is through their combined efforts and coordinated support that we are able to accomplish the objectives and goals set out in our Operations Plan.

A MESSAGE FROM THE CHIEF OF POLICE

It is my privilege as Chief of the Owen Sound Police Service to present the 2023 Annual Report. This is our opportunity as a police service to provide insight and information that summarizes the significant events, demands on resources and milestones of the past year. It is also an opportunity to provide an update on the implementation of the Board's Strategic Priorities.



One highlight early in the year was gathering input from the public and our community partners in the form of a community survey. That feedback, along with a members survey, was very informative and assisted the Board in identifying the Strategic Priorities of the Service - Community Safety, Community Wellbeing, Our Members, and Sustainability. With these Strategic Priorities, the Service then took the information and created an actionable and measurable Operations Plan and assigned the various actions to members of the Service. The 2023-2026 Operations Plan creates a path to achieve the desired results of the Board and community and holds the Service accountable to meeting those priorities. You can look forward to regular updates and milestones as we move forward in the implementation over the coming years. I encourage everyone to read the Operations Plan, monitor the progress, and hold the Service accountable to the implementation. I also encourage you to provide input throughout the life of the plan to properly address the ever-changing issues that we face in providing community policing to our citizens.

Looking back on 2023, there has never been a busier time for our Police Service. The calls for service from the community, the level of violence of those calls and the complexities of the investigations were staggering. Never in the past has there been a year involving so many deaths as a result of criminal acts. Those deaths included the senseless death of Sharif Rahman, a local resident and restauranteur who died tragically after an altercation outside his restaurant. The Service continues to focus attention on these matters as investigations continue and other investigations progress and work their way through the challenges of the judicial system.

It is important to highlight the work of our dedicated members who investigated these incidents and the hours spent seeking justice for the victims who no longer have their voice. Many members of the service, both uniformed and civilian, sacrificed time with their families, to meet the demands of the service in 2023 and that dedication has not gone unnoticed.

The Owen Sound Emergency Communications Centre (OSECC) continues to provide outstanding service to not only the citizens of Owen Sound, but to the other communities across Ontario. Whether it be the professional Communicators answering a frantic call to 911 or the IT professionals who keep our systems running across the province, these dedicated members were called on to meet the demands of the service despite staffing shortages, and never failed to fulfill our commitment. Thank you to all of our members who make the Service run effectively day in and day out. Your hard work and dedication are invaluable to the citizens we serve.

To all of the members of our community, thank you for your cooperation and support and your role in community safety and wellbeing. Without your support and assistance, we cannot provide you the policing services that you deserve and expect.



Owen Sound Police Service's 2023-2026 Operations Plan is a collective result of much time and effort from the Police Service Board, OSPS members, and the community in thoughtfully and constructively sharing feedback, acknowledging successes, and identifying challenges with public safety and delivery of police services in the City of Owen Sound.

In March 2023 the Owen Sound Police Services Board approved the 2023-2026 OSPS Operations Plan. The Plan includes 14 goals and 50 specific actions within the Board's Strategic Priorities of:

OPERATIONS PLAN 2023-2026

YEAR ONE PROGRESS

At the end of the Plan's first year, two actions have been completed; three actions are not started and designed to begin in 2024; and of the other 45 actions 90% are in progress.

Sustainability goal 1, to promote and plan for long term succession, includes one action that has been completed (S1c): by developing a long-term facility plan that anticipates future growth and updates. With the City Facilities Assessment completed in June 2023, short- and long-term facility needs up to the next 10 years can now be aligned and help support long term budgeting, staffing, and IT requirements which are also included within the Sustainability priority.

The other completed action is part of Our Members goal 1, to promote OSPS members' mental and physical wellbeing, by evaluating the shift schedule rotation pattern to maximize member wellness (OM1b).



In partnership with the Owen Sound Police Association, an evaluation was conducted of the 12-hour schedule being piloted. Analysis found overtime and sick time were not significantly influenced and the majority of members agree the new schedule has improved their overall wellness.


OWEN SOUND EMERGENCY COMMUNICATIONS CENTRE (OSECC)

municipalities with an estimated
population of 372,000.

EMERGENCY 9-1-1 CALLS

There were 76,904 calls received from the emergency 911 line in 2023, an increase of 9% compared to 2022. Of the answerable 911 calls, 30% are dispatched by Communicators, and 70% are transferred to a secondary PSAP.


COMPUTER AIDED DISPATCH (CAD)

Calls that are dispatched by the OSECC Communicators come from a variety of sources, such as:

- ∘ the emergency 9-1-1 line
- the non-emergency phone line
- o walk-ins
- officer generated

There were 64,397 calls dispatched by the OSECC in 2023, an 8% increase from 2022. Owen Sound Police Service accounts for the largest volume of dispatched calls in the OSECC: 29% or 18,738 in 2023. The volume of dispatched calls varies by day of week, and by hour of day.



POLICE-REPORTED CRIME, OWEN SOUND POLICE SERVICE 2023

Police-reported crime is measured by a count of the most serious violation within an incident. In 2023, there was a total of 2,566 Criminal Code (CC) violations (excluding traffic) reported to OSPS. This was a 5.6% increase in volume compared to 2022, as a combined result of:

- Violent Crime or Crimes Against Persons increasing +14.6%;
- Crimes Against Property increasing +5.1%; and
- Other Criminal Code Violations decreasing -0.3%.

OFFICE OF THE INDEPENDENT POLICE REVIEW DIRECTOR (OIPRD)

In 2023, a total of 16 OSPS complaints were received by the OIPRD. Fourteen of the complaints were in relation to officer conduct with one additional complaint split into two separate complaints, one being in relation to conduct of officers and one being services provided by the OSPS, however both originating from the same set of circumstances.

One of the complainants filed five individual complaints, the remaining 10 complaints were individual, unique complainants (with one complaint split into 2 totalling 16).

The single service complaint was recently received and remains under investigation. The conduct component of this complaint has been deemed by the OIPRD to be not in the public interest to investigate.

Of the 15 officer conduct complaints, 11 were screened out by the OIPRD who deemed them to be not in the public interest to investigate. A further one was screened out by the OIPRD due to a lack of information to proceed. One was resolved informally between the complainant and subject officer. Another was withdrawn by the complainant prior to the OIPRD making a screening decision. One remains under investigation.



INFORMATION TECHNOLOGY


The Information Technology (IT) branch actively develops and deploys solutions for the Owen Sound Police Service, and other police and fire agencies served by the Owen Sound Emergency Communications Centre. Along with day-to-day help and support, IT maintains the 911 and administrative phone lines, radios, Computer Aided Dispatch (CAD) system, custom applications and ever evolving data analytics.

OSPS's IT branch was the first agency in Canada to transfer Emergency Incident Data Objects (EIDO) and is leading the Next Generation (NG) 9-1-1 call hosted solution development which will be live in 2024. The IT branch's growing portfolio is responsible for systems covering approximately 500,000 residents in 8 counties across the Province.



YOUTH IN POLICING INITIATIVE (YIPI)

The Owen Sound Police Service's Youth in Policing Initiative (YIPI) is a program designed to build and strengthen relationships between police and the citizens of Owen Sound. The program, funded by the Ministry of Children and Community Services, provides employment opportunities for youth 13-18 years old. Throughout the year YIPI students develop skills in delivering information on such topics as crime prevention, social media awareness and bike safety as well as supporting local special events and festivals.




MENTAL HEALTH CRISIS RESPONSE TEAM (MHCRT)

The Owen Sound Police Service and Canadian Mental Health Association (CMHA) Grey Bruce enhanced their partnership in 2023 by adding a full-time crisis worker dedicated to the Owen Sound Police Service.

MHCRT is comprised of a plain-clothed police officer and a CMHA crisis worker who respond as a team to calls for service where mental health or addictions concerns are present.

The main goal of MHCRT is to ensure an individual dealing with mental health or addictions is provided with the most timely and best care possible. MHCRT act as advocates for the individual by making referrals to the appropriate community supports.

MHCRT also conducts training with OSPS officers. By providing officers with additional knowledge and tools, OSPS officers are able to better recognize possible alternatives to apprehensions under the Mental Health Act.



MENTAL HEALTH CRISIS RESPONSE TEAM (MHCRT)



In 2023, OSPS responded to **1,388** mental health related calls for service. During these calls, MHCRT provided support to officers on - scene by providing timely assessments, resources and supports. This immediate MHCRT response led to a 36% decrease in

the number of individuals apprehended under the Mental Health Act compared to 2022.

Placing individuals in timely contact with the appropriate supports alleviates unnecessary admissions to the hospital Emergency Department, provides a better short and long-term support plan and a more dignified outcome for the individual. MHCRT continues to grow "the circle of care" by working closely with other mental health, addictions, housing, poverty and other community organizations striving to provide the best care for those in our community.

COMMUNITY ORIENTED RESPONSE UNIT (CORE)

The CORE unit provides the opportunity for the Owen Sound Police Service to proactively address community issues and concerns, and to alleviate police calls for service. CORE works in partnership with many community agencies to address issues relating to criminal activity, by-law complaints, homelessness, addictions and mental health concerns. CORE also works closely with business owners in the River District, as well as throughout the city, to address specific concerns they may have. Dedicating time to proactivley deal with concerns and fostering partnerships within the community helps provide creative responses to problems, helps prevent calls for service and provides more suitable assistance to those who need it most.



CRIMINAL INVESTIGATIONS

The Criminal Investigations Branch investigates incidents that are more serious in nature and are often more complex. As a result, Detectives complete comprehensive investigations which include identifying and obtaining evidence from victims, witnesses, forensics, video surveillance, electronic devices, as well as other investigative actions, which often include judicial applications. Some of the major investigations that Detectives investigated in 2023 are summarized below.

Aggravated Assault

A male was stabbed multiple times by another male that was known to him, in the 1900 block of 6th Avenue East in May 2023. The male required surgery and was expected to make a full recovery. After a complete investigation, an Owen Sound male was charged with Aggravated Assault, two counts of Assault with a Weapon and Possession of a Weapon for a Dangerous Purpose. The male was convicted in August and remains incarcerated.

CRIMINAL INVESTIGATIONS

Criminal Negligence Causing Death

Police attended the sudden and unexpected death of a 22-month-old child that occurred in a residence in the 400 block of 10th Street West in July 2023. Detectives became involved as it was believed that the child died as a result of a fentanyl overdose. As a result of the full investigation into the circumstances of the death, Detectives charged the child's parents, an Owen Sound man and woman with Criminal Negligence Causing Death and Failure to Provide the Necessities of Life. The child's cause of death was determined to be fentanyl toxicity. The charges are still before the courts.

Second Degree Murder

In July 2023, a 47-year-old male from Toronto was murdered, with the investigation commencing at a residence in the 500 block of 2nd Avenue East. After a thorough investigation into the circumstances of the death, Detectives charged an Owen Sound man with Second Degree Murder as well as other offences, and an Owen Sound woman was charged with Accessory After the Fact to Murder as well as other offences. Both remain in custody with the charges still being before the courts.

CRIMINAL INVESTIGATIONS

First Degree Murder

A 17-year-old male from the Greater Toronto Area was murdered, as a result of what Detectives believe to be a targeted shooting, in an apartment complex on 6th Avenue West in July 2023. After an in-depth investigation, males from North York, Brampton and Owen Sound were all charged with First Degree murder. These charges are still before the courts.

Manslaughter

As a result of a serious assault which occurred in the 900 block of 2nd Avenue East, a criminal investigation commenced based on the level of injury. On August 24th the victim died from his injuries and as a result, the active investigation transitioned into a homicide investigation. This complex and comprehensive investigation continues and remains a priority, with investigators being dedicated to this incident.

DRUGS ENFORCEMENT AND CRIMINAL INTELLIGENCE


Drug Project Conclusion January/February

Members of the Drug Enforcement and Criminal Intelligence Unit concluded an extensive project, "Project Winter", which began in 2022 and focused on targeting drug trafficking on the streets of Owen Sound. The project resulted in five individuals from Owen Sound being arrested and charged with a total of 23 drug related offences and \$8000 worth of illegal drugs being seized, including Fentanyl, Methamphetamine and Cocaine.

Joint Force Operation March


In March, the Drug Enforcementand Criminal Intelligence Unit participated in a Joint Forces Investigation with the OPP Street Crime Unit. The investigation resulted in three search warrants being executed: two at Owen Sound residences; as well as one at a residence in Georgian Bluffs. Large quantities of Cocaine and Canadian currency were seized from all three residences and five individuals were charged in relation to Trafficking Cocaine and Possession of Proceeds of Crime.

BUDGET BREAKDOWN





Executive Summary

This report recommends that correspondence be sent to each member municipality in Grey County seeking their feedback by October 18, 2024 on a proposed planning services model centralized at Grey County and identifies next steps in investigating this potential model.

Background and Discussion

On Thursday, August 8th, the nine Grey County member municipalities met in a joint meeting to discuss a proposal for shared planning services centralized at Grey County. Direction was provided to staff in the closed portion of the meeting to further investigate the centralized planning service model option. A media release was issued on August 21st, 2024 which provided information that the potential servicing model was being investigated.

The County is seeking comments and questions on the centralized planning service delivery model. A municipal decision is not required at this stage, but rather the County is seeking input on the following from member municipalities:

- Questions about service delivery and customer service,
- In person office hours and location of staff,

PDR-CW-52-24 1 September 12, 2024

- Impact on other municipal departments and staff (i.e., building, by-law, engineering, etc.),
- Commentary on other roles served by municipal planners, beyond development application processing and policy review (e.g., heritage permits, community improvement plan applications intake, etc.),
- Questions on the development application process, and reporting to municipal councils and committees,
- Financial, IT (software), legal, or human resources matters,
- Municipal record-keeping,
- Municipal agreements (e.g., site plan, subdivision agreements),
- Timelines or transitional considerations,
- · Communications and reporting between County and municipal staff,
- Future memorandum of understanding considerations, or
- Any other feedback or questions that municipal councils might have.

The above-noted feedback, along with comments received from municipal staff, will help inform the follow-up staff report from County staff. In the next report staff will respond to the comments and questions received, as well as providing more detail on the financial, human resources, IT, and transitional considerations regarding how a centralized planning service delivery model could be implemented. In preparation for the next report, county staff are collecting and assessing information regarding planning department application fees, staff salary and benefits, municipal planning application processes, examples of other county-municipal service delivery memorandums of understanding, and planning department software. This follow-up staff report will be shared with both County and municipal Councils, and it is at that stage that the County will be seeking formal direction on the model.

This proposal is being brought forward in an effort to explore potential opportunities to enhance and improve the efficiency of planning services being provided by the County and member municipalities. It should be noted that local municipal decision-making authority regarding planning decisions would be unchanged under this proposed model. Operational efficiencies would be expected at the administrative level.

Summary

WHEREAS elections rules need to be clear, supporting candidates and voters in their electoral participation and election administrators in running elections; and

WHEREAS legislation needs to strike the right balance between providing clear rules and frameworks to ensure the integrity of the electoral process; and

WHEREAS the legislation must also reduce administrative and operational burden for municipal staff ensuring that local election administrators can run elections in a way that responds to the unique circumstances of their local communities; and

WHEREAS the Municipal Elections Act, 1996 (MEA) will be 30 years old by the next municipal and school board elections in 2026; and

WHEREAS the MEA sets out the rules for local elections, the Assessment Act, 1990 and the Education Act, 1990 also contain provisions impacting local elections adding more places for voters, candidates, and administrators to look for the rules that bind the local democratic process in Ontario; and

WHEREAS with rules across three pieces of legislation, and the MEA containing a patchwork of clauses, there are interpretation challenges, inconsistencies, and gaps to fill; and

WHEREAS the Act can pose difficulties for voters, candidates, contributors and thirdparty advertisers to read, to interpret, to comply with and for election administrators to enforce; and

WHEREAS while local elections are run as efficiently and effectively as can be within the current legislative framework, modernization and continuous improvement is needed to ensure the Act is responsive to today's needs and tomorrow's challenges; and WHEREAS to keep public trust and improve safeguards the Act should be reviewed considering the ever-changing landscape which impacts elections administration including privacy, the threats of foreign interference, increased spread of mis/disinformation and the increased use of technologies like artificial intelligence and use of digital identities; and

On behalf of the Council of the Corporation of the Township of Lake of Bays, please be advised the above-noted correspondence was presented at the last regularly scheduled Council meeting on September 10, 2024 and the following resolution was passed.

"Resolution TC-227-2024

WHEREAS election rules need to be clear, supporting candidates and voters in their electoral participation and election administrators in running elections.

WHEREAS legislation needs to strike the right balance between providing clear rules and frameworks to ensure the integrity of the electoral process,

WHEREAS the legislation must also reduce administrative and operational burden for municipal staff ensuring that local election administrators can run elections in a way that responds to the unique circumstances of their local communities.

WHEREAS the *Municipal Elections Act, 1996* (MEA) will be 30 years old by the next municipal and school board elections in 2026.

WHEREAS the MEA sets out the rules for local elections, the *Assessment Act,* 1990 and the *Education Act,* 1990 also contain provisions impacting local elections adding more places for voters, candidates, and administrators to look for the rules that bind the local democratic process in Ontario.

WHEREAS with rules across three pieces of legislation, and the *MEA* containing a patchwork of clauses, there are interpretation challenges, inconsistencies, and gaps to fill.

WHEREAS the Act can pose difficulties for voters, candidates, contributors and third-party advertisers to read, to interpret, to comply with and for election administrators to enforce.

WHEREAS while local elections are run as efficiently and effectively as can be within the current legislative framework, modernization and continuous

improvement are needed to ensure the Act is responsive to today's needs and tomorrow's challenges.

WHEREAS to keep public trust and improve safeguards the Act should be reviewed considering the ever-changing landscape which impacts elections administration including privacy, the threats of foreign interference, increased spread of mis/disinformation and the increased use of technologies like artificial intelligence and use of digital identities.

WHEREAS the Association of Municipal Managers, Clerks, and Treasurers of Ontario (AMCTO) reviewed the Act and has provided several recommendations including modernizing the legislation, harmonizing rules, and streamlining and simplifying administration.

Whereas the City of Quinte West is entering into an agreement to receive Canada Community-Building Funds, which is administered by the Association of Ontario Municipalities of Ontario (AMO) on behalf of the Federal government;

And whereas the funding allocations are less that 2% year over year for the next 5 years;

And whereas the amounts allocated in the past 5 years were less than 2% year over year;

And whereas non-residential construction price inflation has risen by 29% since the end of 2020 and municipalities are facing soaring costs for infrastructure projects without a corresponding growth in revenue;

And whereas there is a requirement for municipalities to complete an asset management plan and a housing needs analysis;

And whereas both of these plans show the large funding gap between infrastructure and housing needs and funds available from property taxation;

And whereas The City of Quinte West has over \$1.5 billion in core infrastructure assets and, like other municipalities, its infrastructure is aging and in need of upgrades and replacement;

And whereas The City's Asset Management Plan requires \$37 million annually to maintain existing assets which, based on current available funding, is resulting in an annual infrastructure deficit of over \$17.1 million;

And whereas municipalities are facing a gap in federal infrastructure funding as the 10-year Investing in Canada Infrastructure Program has come to an end;

Now therefore be it resolved that the City of Quinte West calls on the Federal Government to provide a supplement to the allocations provided to municipalities under the AMO CBBF agreement for 2024 - 2028 for the same amount that was allocated, effectively doubling the allocation for those years;

Minister Graydon Smith and Associate Minister Nolan Quinn,

Congratulations on your recent appointments within Premier Doug Ford's Cabinet. The Ontario Forest Industries Association (OFIA) looks forward to our productive and continued work together.

Over the last six months, three of Ontario's six pulp and paper mills have permanently closed or idled. Adding to the issue was the closure of a critical softwood pulp market in Quebec. As you know, these facilities served as important consumers of solid-wood byproducts from Ontario sawmills.

The OFIA appreciates the many opportunities we have had to speak with you and senior leadership within Ontario's Ministry of Natural Resources (MNR) and Premier's Office. This includes in-person meetings with members of OFIA's Board Executive Committee on January 19th, March 19th, and May 28th, 2024. During these meetings, the OFIA presented short and long-term actions Ontario could take to address the regional chip and pulpwood market crisis endorsed by the OFIA membership (incl.).

The industry eagerly anticipates government action on this matter, as operating conditions for many have continued to worsen over the past six months. Combined with weak markets for some finished products, many companies struggle to continue their operations. We are now facing an unprecedented challenge in the sector, which could have negative and long-lasting implications for northern and rural communities across Ontario.

Without immediate action in response to OFIA recommendations and, critically, the vetting of potential solutions through the industry to ensure programs truly meet the sector's needs, we fear Ontario could face further curtailments, job losses, and lost economic opportunity.

The OFIA is ready to work with the Ontario government to set the forest products sector on a long-term and stable path towards economic development and prosperity. This includes our

vision of a Forest Energy Directive to develop bioheat, district heating, liquid fuels, renewable gases, biocarbon, and electricity generation projects, supporting Ontario's massive forecasted growth in non-emitting energy demands.

We urge you and your colleagues to continue supporting all measures targeting the immediate challenges the Ontario forest sector faces and look forward to future discussions with you.

WHEREAS it is apparent that the Ontario Government has overlooked the needs of small rural Ontario; AND

WHEREAS Ontario's small rural municipalities face insurmountable challenges to fund both upfront investments and ongoing maintenance of their capital assets including roads, bridges, water/ wastewater and municipally owned buildings including recreational facilities, libraries and other tangible capital assets:

AND WHEREAS small rural Ontario's operating needs consume the majority of property tax revenue sources; AND WHEREAS small rural municipalities (of 10,000 people or less) are facing monumental infrastructure deficits that cannot be adequately addressed through property tax revenue alone; *AND

WHEREAS in 2015 the provincial government moved to standardized billing for all non-contract D.P.P. (5.1) locations; AND WHEREAS the Ontario Government has committed \$9.1 billion to Toronto alone to assist with operating deficits and the repatriation of the Don Valley and Gardner Expressway; and \$534 million to Ottawa for the repatriation of Hwy 174; AND WHEREAS the annual cost of the Ontario Provincial Police, Municipal Policing Bureau for small rural non-contract (5.1) municipalities is approximately \$428 million;

Re: Regulations for the Importation and Safe Use of Lithium-ion Batteries

I am writing today to bring to your attention a matter of significant importance to the Township of Otonabee-South Monaghan, regarding the importation and safe use of lithium-ion batteries.

At the June 17, 2024 Council Meeting the Fire Chief of the Township of Otonabee-South Monaghan made a presentation to Council on the dangers presented by lithium-ion batteries. The Fire Chief was reporting back from attending the Charged For Life Symposium presented by the Office of the Fire Marshal.

During the presentation, the Fire Chief stressed that the increased importation and use of non-Original Equipment Manufacturer (OEM) aftermarket batteries is presenting a significant increase in fire and explosion, putting citizens and responding personnel in danger. These after market batteries are not Underwriter Laboratories of Canada (ULC) certified but can be imported into Canada without any associated regulations.

Unlicensed persons and locations can store and modify lithium-ion batteries in our communities without regulations, providing dangerous conditions within a community. Charging these batteries within the home or multi-unit dwellings can result in larger fires with grave results.

As Canada becomes more aware of Green Energy solutions, these batteries are used more often, increasing the danger to our communities. We support the Ontario Fire Marshal's program to educate citizens on the danger associated with lithium-ion batteries and encourage every municipality to actively promote safe practices for the use of lithium-ion batteries.

We also call upon all levels of government to enact regulations for the importation, sale, storage, and use of non-OEM or ULC certified lithium-ion batteries.

Thank you in advance for your attention to this very critical issue, and I look forward to your prompt consideration and support.

Guide Dog Etiquette **101**



Guide dogs aren't pets. They're partners in mobility for people who are blind, Deafblind, or have low vision.

Although guide dogs are among the most highly trained dogs in the world, they're still dogs. And distracting them while they're working can jeopardize both their safety and the handler's.

By learning and following proper etiquette, you can help make your community more welcoming for guide dog teams.



How to behave around a guide dog

Remember: A guide dog's number one priority is the safety of their handler.



Harness on means hands off. A guide dog in a harness means, "Please don't interact with me. I'm working." As tempting as it may be, never pet, talk to, or make eye contact with a guide dog in a harness.

Contain your excitement. Don't encourage excitable play with a guide dog. Staying calm is part of the job and excitement directed toward them is distracting.

Say "hello" another time. If you approach a guide dog team with your pet dog, keep your dog on a leash and away from the guide dog.





Hands off & no treats

Never grab a guide dog's harness or leash, or try to steer their handler. This can be disorientating and dangerous for the guide dog and the handler.

Never offer food or treats to a **guide dog.** This can result in disruptive behaviours like begging for food and scavenging off the ground.



Work hard, play hard

There is time for play! When their harness is off and they're not working, guide dogs are like any other dog. They love to play, run around, cuddle with humans, and relax.



Don't discriminate

Guide dogs belong everywhere.Guide dog teams are allowed access to any premises the public would normally have access to. It's the law.



It's okay to offer help

Before offering your assistance, you should always ask if it's needed. When approaching a guide dog handler, introduce yourself and always speak directly to the handler, not the guide dog.



Educate and advocate

Help champion equal access for guide dog teams. If you encounter someone not following proper guide dog etiquette, politely remind them not to distract the guide dog.






Victim & Perpetrator Age Comparision




Cause of Death

MONTHLY HIGHLIGHT



In August, 7 femicide cases were confirmed in Ontario. Since November 26, 2023, a total of 49 femicides have been confirmed within the province. This year on average, 5 femicides occur each month in Ontario, a trend similar to what has been seen in the province the two years prior.

While femicides are most commonly reported to be perpetrated by an intimate partner, there continues to be a proportion of femicides in Ontario, where family members have been charged or deemed responsible. This year, family perpetrated femicides account for 20% of confirmed cases (or 10 cases) to date. These cases include victims under the age of 17, who died alongside their mothers in the context of intimate partnerviolence and whose fathers died by suicide but were deemed responsible in the death of the victim and the victim's mother. These cases also include older victims, aged 55 and older, whose son or grandson has been charged in relation to their deaths. While these cases may not occur within the context of IPV, they highlight the ongoing caregiver role that is placed upon mothers and grandmothers extending into adulthood. In some cases the men charged have a reported history of perpetrating violence against the victim or against other women in their lives such as an intimate partner, or at times, may have previous charges/convictions for other violent offences. Despite the ongoing trend of family perpetrated femicides, currently there is no policy framework or mechanism to review femicide cases perpetrated by sons or grandsons, to determine how various systems and services could have intervened or prevented these killings.

While efforts are being made to improve femicide data collection, in order to ensure accurate data collection that demonstrates the full scope of the issue, femicide definitions must be inclusive of not only intimate partner femicides, but also other forms of gender-based violence such as family perpetrated femicides.
