# **Background:**

At the September 11, 2024 River District Board Meeting, a member of the public asked a question about what the River District Board was doing to support businesses in the River District and identified issues relating to drug use and homelessness that are impacting the area.

Following that meeting, staff met with the Chamber of Commerce and Chair of the Board and then convened a meeting inviting community partners to attend a meeting on October 18, 2024.

City staff facilitated the meeting and attendees were asked the following questions:

- Highlight the services or work by your organization that supports
  people who are homeless or who are living with mental health issues
  and addictions.
- In 2 words describe your vision for the River District.
- Brainstorming gaps and opportunities to work collaboratively to fill the gaps.

A subsequent meeting of the partners will be held to further discuss ideas and opportunities that were raised by those in attendance including:

- River District Outreach Role (Unity Project) (proactive);
- Education;
- Communication;
- Housing and wrap around support;
- Shelter;
- Funding gaps;
- Public washrooms; and
- Poverty reduction.

### **Financial Implications:**

Poverty was noted as a critical issue.

Many of the agencies at the table are funded, in part, through private donations and funds or grants that are not a stable source of funding.

It is acknowledged that there will be costs to exploring the ideas to fill the gaps.

# **Communication Strategy:**

Ongoing with agencies, City and River District Board and businesses.
