8.a Report CM-25-008 from the Senior Manager of Strategic Initiatives and Operational Effectiveness Re: Vision 2050 - February 2025 Update

The Senior Manager of Strategic Initiatives and Operational Effectiveness provided an overview of the report.

Deputy Mayor Greig joined the meeting at this time.

In response to a question from Committee, Ms. Palmer noted that the strategic planning process includes long, medium, and short-term actions that can take place over the next 25 years. Additionally, Mayor Boddy clarified that the Vision 2050 plan isn't just for the year 2050, but that it encompasses the next 25 years and will be adaptable and flexible to change over that time.

In response to a question from Committee, Ms. Palmer clarified that the engagement report coming to the Committee in March will share the information gathered from the public engagement, and then the final report coming to the Committee in May will layout the 2050 Vision plan as a whole. Additionally, she noted that measurables will be included within each of the plan's priorities that can be used to monitor implementation of the plan as action items are completed.

In response to a question from Committee, Ms. Palmer noted that the delay in providing the engagement report is due to the significant volume of data gathered during the engagement process and the review of that data. Additionally, she clarified that there are no further community engagement opportunities currently planned for Vision 2050. Public and stakeholder engagement has been a prominent focus throughout the process and will continue to be so while the plan is implemented over the years.
