### 7. DEPUTATIONS AND PRESENTATIONS

7.a Deputation from Jamie Walpole Re: Festival of Northern Lights Update

Jamie Walpole, Festival of Northern Lights organizer, provided a presentation about the 2024 festival season, including highlights, challenges, and demographic information about festival attendees. Mr. Walpole noted that the organizing team is working to grow its volunteer and sponsorship bases.

In response to questions from Council, Mr. Walpole noted that efforts to prevent vandalism are ongoing and provided examples of prevention efforts.

In response to a question from Council, Mr. Walpole advised that the City supports the Festival by providing use of City-owned storage facilities and staff assistance with set-up and tear-down of displays.

In response to questions from Council, Mr. Walpole advised that volunteers with all skill sets are welcome, including high school students in need of volunteer hours. Mr. Walpole advised that information about sponsorship opportunities will be posted on the Festival's website and Facebook page.

7.b Presentation from the City Manager Re: City Manager's Update

The City Manager provided a PowerPoint presentation and noted:

- Registration is open for children's summer camps;

8.a Joachim Ostertag, Owen Sound resident

Mr. Ostertag, a member of Climate Action Team Owen Sound (CATOS), provided comments in support of the addition of a Festival of Northern Lights display memorializing the victims of the 1989 Montreal Massacre.

Mr. Ostertag reiterated the comments he made during the March 6 meeting of the Corporate Services Committee and highlighted his previous suggestion that the City increase the level of public engagement it undertakes with respect to climate action. Mr. Ostertag requested further information about the Tree Cities of the World designation.

The Director of Corporate Services advised that staff apply for the Tree Cities of the World Designation and receive it based on the results of the application's scoring.

8.b David Walton, Owen Sound resident

Mr. Walton provided suggestions respecting soliciting ideas for climate action from frontline staff. Mr. Walton further provided suggestions for the clean-up of excess salt on roads and walkways.

Mayor Boddy advised that excess salt leftover from winter control will be swept once snowbanks have completely melted.

8.c Hilary Coburn, Owen Sound resident

Ms. Coburn provided comments suggesting that the City create a staff position dedicated to climate action.
