1. CALL TO ORDER

Mayor Boddy called the meeting to order at 3:00 p.m.

2. DECLARATIONS OF INTEREST

2.a Councillor Hamley – Item 6.a – Report CM-25-014 from the City Manager and the City Clerk Re: Strong Mayor Powers

Councillor Hamley declared a conflict of interest with discussions arising out of Item 6.a of the agenda, due to his personal employment with the Government of Ontario.

5. DEPUTATIONS AND PRESENTATIONS

5.a Presentation from John Mascarin, Aird & Berlis LLP Re: Strong Mayor Powers

The City Manager introduced John Mascarin, Senior Partner, Aird & Berlis LLP. Mr. Mascarin gave a PowerPoint presentation providing education respecting strong mayor powers.

Mr. Mascarin provided information about the statutory and regulatory sources of strong mayor powers, as well as the types of powers given to mayors who have been granted these powers. Strong mayor powers include administrative, provincial priority powers and budget powers as well as other miscellaneous abilities. Mr. Mascarin highlighted processes associated with utilizing these powers.

In response to questions from Council, Mr. Mascarin noted that when strong mayor powers are used to hire a CAO, the legislation does not require that the employment contract be shared with Council.

In response to a question from Council, Mr. Mascarin advised that there is no quick mechanism through which Council can challenge whether a mayor has acted within or beyond their authority, and that such challenges will need to be heard by the courts.

In response to a question from Council, Mr. Mascarin advised that a mayor has authorization under the statutes to make certain hiring and dismissal decisions, and that the absence of requirements for mayors to consult with human resources personnel raises questions of liability for municipalities.

In response to a question from Council, Mr. Mascarin advised that strong mayor powers don't supersede other rights or requirements under the *Planning Act*, including appeal rights.

In response to a question from Council, Mr. Mascarin noted that a mayor could put a budget process in place that is very similar to what existed prior to this legislation, now referring to it as the Mayor's budget.

In response to a question from Council, Mr. Mascarin advised that the only mechanism to challenge whether a mayor acted in good faith in the exercise of strong mayor powers is through the courts. Mr. Mascarin advised that a mayor's exercise of strong mayor powers is a legal question not an ethical question, and therefore outside the jurisdiction of an integrity commissioner.

In response to a question from Council, Mr. Mascarin advised that Council could enact policies, procedures, or by-laws in an effort to enhance transparency with respect to the use of strong mayor powers but that the mayor would not be legislatively required to follow them.

In response to a question from Council, Mr. Mascarin noted that the Province accepted comments on the expansion of strong mayor powers from April 9 to 16, 2025. Mr. Mascarin advised that if Council passed a resolution opting out of strong mayor powers and the mayor agreed to it, the Minister might consider that request.

In response to a question from Council, Mr. Mascarin advised that the legislation does not currently include 'lame duck' provisions for an outgoing head of council.

Mr. Mascarin provided responses to questions submitted by Council, as attached to Staff Report CM-25-014.

NOW THEREFORE BE IT RESOLVED THAT a reply be sent from the City of Owen Sound to the Minister of Municipal Affairs and Housing requesting that the Ministry reverse the decision and immediately remove the City of Owen Sound from the list of municipalities designated under strong mayors legislation;

AND FURTHER THAT the letter be copied to the Premier of Ontario, M.P.P. Paul Vickers, and the Association of Municipalities of Ontario (AMO);

AND FURTHER THAT a formal response be requested from the Minister of Municipal Affairs and Housing."
