## 6. PUBLIC MEETINGS

6.a Zoning By-law Amendment (ZBA) No. 55 - 1115 10th Street East (Paaji Inc.)

Mayor Boddy declared the Public Meeting open at 5:33 p.m. and read the following announcement:

- Thank you for attending tonight's public meeting. The purpose of this
  meeting is to receive input from the public respecting the proposed
  amendments to the Zoning By-law as per Section 34 of the *Planning Act*.
- In a few moments the Manager of Planning and Heritage will present background information regarding the requested amendment. Following the presentation, we will hear from the applicant and then we will open the floor for comments, questions, and feedback from the public.
- All submission materials for this application are available on the City's website and at the Planning Division counter at City Hall during regular business hours.
- Recent amendments to the *Planning Act* by the Province now limit appeal
  rights on a Zoning By-law amendment application to the applicant, public
  bodies, and specified persons who made oral or written submissions to
  Owen Sound City Council prior to a decision being made. Specified
  persons generally include energy, railway and telecommunication
  providers as well as NAV Canada.
- This meeting is an essential part of the decision-making process.
   Feedback received will be considered in the decision of the Owen Sound City Council. An explanation of how the public and agency comments factored into the decision will be included in the Notice of Passing of the By-law.

Where a change is made in a proposed by-law after the holding of the
public meeting, Council will determine whether any further notice is to be
given respecting the proposed by-law and the determination of Council as
to the giving of further notice is final and not subject to review in any court
no matter the extent of the change made in the proposed by-law.

The City Clerk explained that notice of the Public Meeting was posted on the subject property, circulated to the prescribed persons and bodies, and placed on the City's website on May 23, 2025. All comments received prior to the agenda being published were attached to the agenda. One comment was received after the publication of the agenda and before the public meeting, which was circulated to Council and attached to the re-published agenda following the meeting. The City Clerk encouraged those present for the public meeting to sign the sign-in sheet located on the table outside of Council Chambers.

The City Clerk advised that personal information is collected under the authority of the *Planning Act*, and that the information collected will be used to complete the Zoning By-law Amendment (ZBA) process and will form part of the public record. Questions about this collection should be addressed to the City Clerk.

The City Clerk advised that any person wishing to receive notice of the decision of The Corporation of the City of Owen Sound on the proposed Zoning By-law Amendment application must make a written request to the City of Owen Sound.

The Manager of Planning and Heritage provided a presentation on Zoning By-law Amendment No. 55 put forward by Ron Davidson on behalf of Paaji Inc. for the conversion of and addition to the existing building to create 36 residential apartment dwelling units. Ms. Robart highlighted the location of the subject lands, noting that the lands are designated Residential in the City's Official Plan. The lands are zoned as Institutional in the City's Zoning By-law.

Ms. Robart highlighted the ZBA process to date and advised that a recommendation report and enacting by-law are tentatively scheduled to be presented to Council on July 7, 2025.

Ron Davidson, Planning Consultant for the developer, advised that the property owner was present. Mr. Davidson provided an overview of the pre-consultation process undertaken prior to submitting the ZBA application. Mr. Davidson advised that the proposal conforms to the City's Official Plan and is consistent with the Provincial Planning Statement, specifically with regard to its proximity to recreation, education, healthcare, public transit and commercial amenities. Mr. Davidson noted that any increase in traffic volume related to the proposed development is expected to be negligible, and that provisions for perimeter fencing and stormwater management were addressed during pre-consultation and will be refined during later stages in the development approval process.

Mayor Boddy invited members of the public to ask questions or provide comments on the ZBA.

Tony Bach, Owen Sound resident, asked if the development would include low-income or market-rate rentals.

Mr. Davidson advised that while the proposed development is intended to provide housing for young professionals, the Zoning By-law cannot stipulate rental rates.

James Harris, Owen Sound resident, asked if the development will include non-market rentals.

The Director of Community Services advised that the proposed development is for rental apartments and that Council cannot regulate if the units are priced at affordable or market rents.

Tom Fordham, Owen Sound resident, asked if the units would be developed as public housing and about the height of the addition in comparison to the existing

structure. Mr. Fordham provided comments in opposition to the proposal, citing concern about privacy and the size of the proposed building addition.

Vivian Bignell, Owen Sound resident and member of the Bayview Heights Condominium Corporation Board, spoke in opposition to the proposed development and noted her concerns about noise, snow removal, water run-off, privacy, traffic and disruptiveness of construction activities. Ms. Bignell inquired about the sufficiency of the proposed 5-foot perimeter fence and about Council's ability to stop the proposed zoning change.

Diane Bettel, Owen Sound resident, inquired about the distance between the development and 10<sup>th</sup> Street East.

Tom Fordham, Owen Sound resident, provided further comments expressing concern about the proposed development interfering with sunlight reaching his backyard garden.

The Director of Community Services reminded those in attendance for the Public Meeting to include their contact information on the sign-in sheet so that the City can communicate next steps.

There being no other comments, Mayor Boddy declared the Public Meeting closed at 6:08 p.m.

The Manager of Planning and Heritage left the meeting.

7.a Presentation from Mayor Boddy Re: OPP Commissioner's Citation for Heroic Rescue

Mayor Boddy recognized firefighter Jay Gow of Owen Sound Fire and Emergency Services for his recent receipt of an Ontario Provincial Police (OPP) Commissioner's Citation for Lifesaving. Mr. Gow, along with two members of the Inter Township Fire Department, were recognized by the OPP Commissioner for their heroic rescue of three men trapped in a collapsed grain silo in 2024. Mayor Boddy thanked Mr. Gow for his dedication and service to the community.

The Fire Chief and Owen Sound Firefighters left the meeting.

7.b Deputation from Olive Borowski Re: Banditfest Youth Music Festival

Olive Borowski, student and organizer of Banditfest Youth Music Festival provided an overview of events planned for Banditfest 2025 and noted the event's alignment with the River District Action Plan and the Grey County Age-Friendly Action Plan. Ms. Borowski requested that Council support the event by authorizing the closure of 1<sup>st</sup> Ave. E. between 9<sup>th</sup> St. E. and 10<sup>th</sup> St. E., as well as use of the adjacent River District Boardwalk, on July 13, 2025, from 7 a.m. to 7 p.m.

The City Manager advised that staff are aware of the event and will facilitate the requested road closure.

7.c Presentation from the City Manager Re: City Manager's Update

The City Manager provided a PowerPoint presentation and noted:

- Ongoing City projects including road line painting, water meter replacement, tree planting, and seasonal ice rink removal;
- Road rehabilitation is beginning at the intersection of 9th Ave E. and 6<sup>th</sup> St. E., and detours will be in place during the construction;
- Upcoming events and community engagement opportunities;

- Reports that will be presented to upcoming meetings of the Corporate Services Committee, Operations Committee, Community Services Committee, as well as the dates of other meetings; and
- A listing of media advisories issued since the last update.
