# 8. PUBLIC MEETINGS

The Manager of Planning and Heritage joined the meeting at this time.

a. Zoning By-law Amendment No. 32 - Sydenham Campus

Mayor Boddy declared the Public Meeting open at 7:08 p.m. and read the following announcement:

- Every person who attends a statutory public meeting required under the Planning Act shall be given an opportunity to make representations in respect of the proposed By-law.
- All submission materials for this application are available on the City's website and at the Planning Division, City Hall during regular business hours.
- If a person or public body would otherwise have an ability to appeal the
  decision of the City of Owen Sound to the Local Planning Appeal Tribunal
  but the person or public body does not make oral submissions at a public
  meeting or make written submissions to the City of Owen Sound before the
  zoning by-law amendment is passed, the person or public body is not
  entitled to appeal the decision.
- If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Owen Sound before the zoning by-law amendment is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

The City Clerk explained that notice of the Public Meeting was circulated to the prescribed persons and bodies, published in the Sun Times newspaper, and posted on the City's website on January 19, 2021.

The City Clerk advised that personal information is collected under the authority of the *Planning Act* and the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, and that the information collected will be used to complete the Zoning By-law Amendment process, and will form part of the public record. Questions about this collection should be addressed to the City Clerk.

The City Clerk noted that those wishing to be notified of the decision of The Corporation of the City of Owen Sound on this proposed Zoning By-law Amendment must make a written request to the City of Owen Sound care of the City Clerk.

The Manager of Planning and Heritage provided a presentation on Zoning Bylaw Amendment No. 32. Ms. Cann highlighted the location of the subject property and noted that the lands are currently zoned as Institutional (I).

Ms. Cann provided an overview of the amendment being requested, and advised that the applicant has submitted a Site Plan Approval application to be processed concurrently with the Zoning By-law Amendment application.

Grey County's Director of Economic Development, Tourism, and Culture, Savannah Myers, and Senior Planner Scott Taylor provided a presentation on the proposed Zoning By-law Amendment, noting that the County's intent for the former Sydenham school property is to create a regional skills, training, and innovation centre called 'Sydenham Campus'. The Centre is designed to support small businesses, and will be home to the Small Business Enterprise Centre, Community Futures Development Corporation, fabrication labs, post secondary training, a day care/childcare facility, and flex spaces for businesses and events. The goal for Sydenham Campus is to operate on a cost recovery basis, with the requirement for tenants to be giving back through collaborating with other businesses located in Sydenham Campus, providing training, sharing equipment, or by providing mentoring services.

The City Clerk advised that Brian and Maria Jones, Owen Sound residents, registered to provide comments at this Public Meeting.

Maria Jones expressed concerns that she and Brian have regarding parking and traffic in the areas around Sydenham Campus. Ms. Jones advised that parking has historically been an issue on 11th Avenue, with individuals from Georgian College parking on 11th Avenue and walking to the college to avoid parking fees. Ms. Jones acknowledged the sign at Sydenham Campus indicating that the lot is for Sydenham Campus parking only, and that Georgian College parking is next door, but anticipates that Sydenham Campus may have a similar issue with individuals from Georgian College parking in their lot.

There being no other speakers, Mayor Boddy declared the Public meeting closed at 7:40 p.m.

b. Official Plan Amendment No. 10 - Official Plan Update

Mayor Boddy declared the Public Meeting open at 7:41 p.m. and read the following announcement:

- If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Owen Sound before the proposed official plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

The City Clerk explained that notice of the Public Meeting was circulated to the prescribed persons and bodies, published in the Sun Times newspaper and posted on the City's website on December 29, 2020, and again on January 8, 2021.

COUNCIL - REGULAR Meeting Minutes - February 8, 2021

The City Clerk advised that personal information is collected under the authority of the *Planning Act* and the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, and that the information collected will be used to complete the Official Plan Amendment process, and will form part of the public record. Questions about this collection should be addressed to the City Clerk.

The City Clerk noted that those wishing to be notified of the decision of The Corporation of the City of Owen Sound on this proposed Official Plan Amendment must make a written request to the City of Owen Sound care of the City Clerk.

Dave Aston of MHBC Planning provided a presentation on the proposed Official Plan amendment. Mr. Aston advised that the City's current Official Plan was adopted in 2006, and is being updated to address changes in the City, ensure consistency with the Provincial Policy Statement, and assess conformity with applicable planning policies such as the Grey County Official Plan.

Mr. Aston advised that community engagement is an important part of updating an Official Plan, and noted that community engagement has been conducted throughout the Official Plan review process. Discussion papers were prepared to inform and engage stakeholders in the areas of sustainability and climate change; housing and affordability; transportation and infrastructure; and land use and design. These discussion papers will form the draft Official Plan policies.

Mr. Aston advised that the next steps in the Official Plan review process is to consider comments received from the public and commenting agencies, host a special meeting of Council to discuss the Official Plan update, finalize the Official Plan and prepare a recommendation report for Council's consideration, and pending Council's approval, forward the Official Plan to the County of Grey for final approval.

The City Clerk advised that Shawna Macivor and Peter Middleton registered to provide comments at this Public Meeting. Ms. Bloomfield noted that Mr. Middleton was connected at the beginning of the meeting, but has since lost connection.

Shawna Macivor, Georgian Bluffs resident and representative of NeighbourWoods North, advised that the City's new Official Plan is intended to span over a 25 year period, just four years short of Canada's goal of reducing greenhouse gas emissions to zero by the year 2050. Ms. Macivor added that Owen Sound's draft Official Plan does not yet conform to Provincial and County policy as it makes little mention to climate change.

Ms. Macivor requested that the City of Owen Sound create an environmental committee that draws on the expertise of those in Owen Sound and surrounding areas, adding that an environmental committee could promote cooperation and harmony between the City and its residents with respect to the environment. Lastly, Ms. Macivor advised that the City's Official Plan should contain a provision for protecting the tree canopy. Ms. Macivor highlighted the importance of trees and the benefits they have, and stated that the City should have a line-item in the budget specifically for trees.

There being no other speakers, Mayor Boddy declared the Public Meeting closed at 8:10 p.m.

The Manager of Planning and Heritage left the meeting at this time.

Ms. Allan advised that the commenting period on the 2021 Budget was extended with no additional comments from the public being received. Ms. Allan noted that the City is estimating a combined increase of 1.85 percent for residential taxes.

Lastly, Ms. Allan highlighted the average tax increase of municipalities in the County of Grey, noting that the City of Owen Sound's tax increase for 2021 is the lowest in the County of Grey.

Mayor Boddy thanked staff for their hard work in putting together the 2021 Budget.

Lastly, Councillor Thomas advised that the Grey Bruce Health Unit is continuing to work on the opioid crisis in the area. A sharps disposal unit has been installed in downtown Owen Sound, and the needle exchange program, naloxone distribution, and regular opioid working groups continue.

#### a. Snow Removal Winter Control Operations

The Director of Public Works and Engineering advised that the City experienced a heavy snowfall this past weekend, with approximately 25 centimeters being deposited. The City's Public Works staff worked diligently throughout the course of the weekend to ensure that roads and sidewalks were cleared and safe for use.

#### b. Attendance at Virtual ROMA Conference

Councillor Merton advised that she participated in the Rural Ontario Municipal Association's virtual conference from January 25 - 26, 2021, where she participated in four concurrent sessions titled 'Come Hell or High Water: Actions to Mitigate Flooding', 'Now What? An Open Conversation on Community Safety and Well-Being Plans', 'The Pathway to Full Producer Responsibility of the Blue Box', and 'The Science Behind Implicit Bias'. Councillor Merton thanked the City and residents for allowing her to attend this virtual conference, and advised that the knowledge gained, and the opportunity to connect with other rural municipalities was beneficial and will aid in moving forward during COVID-19.

# c. SNOWen Sound Event

Councillor Koepke highlighted the 'SNOWen Sound' event that is currently taking place in Owen Sound. The event is taking place at various locations throughout the City, and those interested in participating are invited to visit the City's website for more information on how to get involved.

# d. Mayor's Update

Mayor Boddy welcomed the announcement by Hydrogen Optimized on Friday February 5, 2021 where they announced that they have taken a major step towards their goal of becoming a global leader in large-scale green hydrogen productions by securing a new technology and manufacturing centre in Owen Sound.

Mayor Boddy thanked Peter Van Dolder and his partners for their foresight and investment in the City of Owen Sound. Mr. Van Dolder's investment will work to keep industrial buildings and ownership local, which will work toward the best interests of the City of Owen Sound as a whole by finding tenants that will create jobs and give back to the community.

Mayor Boddy advised that 2021 is the year of the Ox. Lunar New Year begins Friday February 12<sup>th</sup> and lasts 16 days ending February 26<sup>th</sup> with the lantern festival. The Grey Bruce Chinese Heritage and Culture Association will be hosting the Grey Bruce Lunar New Year Celebration to acknowledge that Lunar New Year is celebrated by many countries worldwide. Watch for activities at Grey Roots Museum and Archives and the Owen Sound Library, and visit the Grey Bruce Chinese Heritage and Culture Association's Facebook page for more information.

Mayor Boddy advised that Canada is celebrating the 25th Black History Month, where we can celebrate and recognize the important contributions that Black Canadians have made in shaping the development, heritage, and growth of our country and City. In 1872, 672 individuals of African ancestry travelled to Owen Sound thorough the underground railroad and made up approximately 10 percent of the population of Owen Sound.

Mayor Boddy advised that the historic British Methodist Episcopal (BME) Church was established in 1856 in Owen Sound and later moved to its current location 110 years ago. Mayor Boddy noted that Addie Aylestock was a Deaconess at the BME Church, and became the first ordained female minister of the BME and first Black-Canadian Minister in Canada in 1951. Lastly, Mayor Boddy advised that the City is looking forward to marking the 159th Emancipation Festival at Harrison Park this summer, which has taken place every year since the British Government enacted the *Emancipation Act*, 1962.
